Staff Recommendation: APPROVAL to print for purposes of Planning Board Public Hearing, to be scheduled in January

The planning process is outlined in *Figure 1*.

Description of Little Bennett Regional Park

Little Bennett Regional Park is located northwest of Clarksburg (see figure 2- Location Map).

With over 3,600 acres, Little Bennett Regional Park is the largest park in the M-NCPPC park system and is one of our best natural areas. The park is bisected by Little Bennett Creek, a class III stream that supports one of the few brown trout fisheries in the County. There are 11 historic sites in the park including the Montgomery Chapel Cemetery, Zeigler Log House, Hyattstown Mill and Kingsley School House.




Figure 3 - Existing Facilities Map

Existing park facilities (figure 3 - Existing Facilities Map) include a 91-site campground, 18 hole golf course and driving range, over 23 miles of natural trails and a maintenance yard with offices for park personnel. Approximately 67.500 visitors come to the park every year to enjoy hiking, cycling, birding, camping, fishing, horseback riding, plant walks, interpretive programs and golf.

Planning Background





Figure 4 - 1985 Concept Plan

The current park master plan was completed in 1985 (see figure 4). The Plan includes recommendations for a Future Family Camparound, a Group Camparound, a Swim Facility, a Day Use Facility, a Visitors Center, an Outdoor Education area, and a Golf Course Complex. The golf course and driving range were opened in 1994. Since then, there have not been any large capital improvement projects in the park.

Instead, Staff efforts have concentrated on management of the existing facilities and protection of the natural and cultural resources.

As part of the Staff Draft Master Plan for Little Bennett Regional Park, recommendations from the 1985 Concept Plan have been reevaluated. The Staff Draft Plan proposes changes to the pattern and type of uses proposed for the park but the guiding principle of the 1985 Plan remains unchanged:

Development at Little Bennett should emphasize the park's natural features, beauty and tranquil environment while at the same time providing Montgomery County residents with a variety of recreation experiences oriented to this unique outdoor setting.

Overview of Staff Draft Plan

The proposed *Staff Draft Master Plan map* for Little Bennett Regional Park is shown in *Figure 5.* In January 2006 the Planning Board reviewed and approved planning objectives to guide the master plan process. These are listed in *Table 1*. The plan recommendations for realizing these objectives are also included. More detail on the recommendations may be found in the Staff Draft Plan.

The Plan objectives reflect the Planning Board's request at the January worksession to accommodate the potential future need for athletic fields. This has been done by proposing an area for parkland acquisition that lies outside the portion of the park proposed for a natural focus.

A plan objective relating to planning for the future of the golf course has been removed. The 18-hole Little Bennett Golf Course opened in 1994. More than 20,000 golfers enjoy the course every year. One approach to attract more golf course use may be to provide family oriented facilities and group event areas near the golf course. This and other options, such as providing a golf-learning center, will be explored during a separate Master Plan for the golf course being prepared by the Montgomery County Revenue Authority.

The Staff Draft Plan proposes Implementation strategies and includes background studies that have helped shape the Staff Draft Plan recommendations.

Overview of Public Participation Process

The public participation process began in November 2005 with a community "kick off" meeting. Additional public meetings were held April and October 2006.

Staff have also attended the following meetings to seek input from interested groups and civic organizations: Legacy Open Space Advisory Board, Montgomery County Historic Preservation Commission, Clarksburg Civic Association, Clarksburg Citizens Advisory Committee and Upcounty Recreational Advisory Committee.

Jennifer Russell, Clarksburg Ombudsman for the County Executive, arranged meeting with Executive branch staff to review and comment on the Draft Plan concepts. Meetings were also held with planning staff from Frederick County Planning Department and with representatives from the Hyattstown Fire Department.
