The applicant filed the subject Project Plan application for Clarksburg Town Center on July 9, 2007. Section D-2.2 of the Zoning Ordinance provides that the Planning Board shall hold a public hearing no later than 90 days after the filing of a project plan. The Planning Board, however, can extend this time period.

Staff recommends extension of the review period for the Project Plan and postponement of the hearing in order for the Applicant to respond to agency comments. The hearing for the Project Plan application will be extended for an additional 90 days.
