APPLICATION DESCRIPTION:

Amendment to modify site plan elements necessitated by the following: (1) site conditions discovered through enforcement action including modifications to landscaping, street lighting, striping and pedestrian connections; and (2) revisions requested within the right-of-way by the Department of Permitting Services. Property is 62.55 acres in the R-200/TDR-4 zone; located on Little Seneca Parkway; in the Clarksburg Master Plan area.

**RECOMMENDATION:** 

Approval of site plan amendment and adoption of draft resolution No. 11-25.

**EXECUTIVE SUMMARY:** 

The Applicant desires to add, eliminate, and/or modify certain plan elements that were approved as part of the original site plan, which include street lighting, striping, and pedestrian connectivity. The site plan amendment was necessitated due to a Notice of Violation issued by the Department of Permitting Services Site Plan Enforcement Section, for modifications, additions, and/or deletions to elements on the approved certified site plan. No setbacks or other development standards are being amended.

#### SITE DESCRIPTION:

#### **Vicinity**

Access to the development is located off Little Seneca Parkway, approximately 1000 feet west of Frederick Road (Rte 355). Little Seneca Parkway is master planned to provide a future connection from Route 355 to 1-270. Directly to the north of the subject property is the Board of Education property known as Clarksburg High School. Adjacent to the subject property east toward Rte 355 is Rocky Hills Middle School. The property is in the Clarksburg Special Protection Area.

The property to the south and west of the Meadows at Hurley Ridge is owned by Comsat, housing a number of associated technology buildings, and zoned 1-3. The property to the southeast, across Little Seneca Parkway, is the Clarksburg Heights (Preliminary Plan #1-89084) subdivision. This development consists of a mix of single-family attached and detached units and is zoned R-200/TDR. The property directly to the southwest, known as the Linthicum Property (Preliminary Plan #1-02015), consists of a mix of single-family housing types. Zoning for this site is R-200 to the east of the stream, and 1-3 and 1-4 to the west toward 1-270.

#### **SITE ANALYSIS:**

The subject site is currently improved per Site Plan 82003011B, which consists of 219 single-family attached and 31 single-family detached dwelling units including 87 TDR's and 41 MPDUs, on 62.55 net acres, of which 5.43 acres were placed into a category I forest conservation easement. No other environmental features or rare, threatened, or endangered species exist on the property. There are no known historic properties or features on the site.

#### **PROJECT DESCRIPTION:** Prior Approvals

#### **Preliminary Plan**

On April 4, 2002 preliminary plan # 120020110 was approved for 325 lots (104 SFD's and 216 SFA units) on 102.9 acres, including 113 TDR's and 41 MPDU's. The subdivision was known as the "Martens Tract" and was developed in two phases with two separate site plans. The site conforms to the conditions of the approved Preliminary Plan.

#### Site Plan

On May 20,2003 the Montgomery County Planning Board issued a written opinion approving site plan #820030110, which included 219 single-family attached and 31 single-family detached dwelling units including 87 TDR's and 41 MPDUs. This site plan was the second of the two phase development.

Two additional minor amendments; 82003011A & 82003011B were approved by staff in 2004 and 2005 respectfully. These amendments were filed to adjust property lines for lots 57-67 & 68-64 Block P, and the greenway/natural surface trail alignments.


#### SITE PLAN VIOLATION:

Site plan amendment #82003011C was submitted in response to a Notice of Non-Compliance issued by the Department of Permitting Services, Site Plan Enforcement Section on May 28, 2010 (Exhibit B). A compliance date of July 1, 2010 was given to the applicant, which was extended by DPS for 60days extension was granted by DPS in order for the applicant to address the enforcement items and submit an amendment to the site plan. Based upon the as-built site conditions, the site plan could not be brought into conformance with the approved plans.

On November 15, 2010 DPS Site Plan Enforcement Section issued four (4) \$500 civil citations to the Applicant (Exhibit C), for making changes to site plan elements without approval. The Applicant contested the citations. The District Court of Maryland for Montgomery County scheduled a trial to hear the case on December 21, 2010. The original trial was postponed and rescheduled for March 15, 2011. An abatement order was issued by the District Court of Maryland for Montgomery County on March 15, 2011 (Exhibit D). The abatement order prescribes the applicant to complete several elements from the site plan that were not originally completed, which include installing several private street lights and miscellaneous trees and shrubs throughout the community. The abatement order specifies the remainder of the work be completed by July 15, 2011.

#### CONFORMANCE TO CONDITIONS OF APPROVAL:

The proposed development complies with the conditions of approval for Site Plan 820030110 with the exception of the enforcement items described herein.

#### **DESCRIPTION OF CURRENT AMENDMENT:**

The Applicant requests the following modifications to the Site Plan:

- 1. Revise public street light locations throughout the development, due to site constraints and as-built conditions.
- 2. Add retaining walls for a sidewalk connection along Fair Garden Lane and relocate street trees impacted by the sidewalk.
- 3. Revise bike path connection along Route 355 and crosswalk striping changes requested by MCDOT.

#### **PUBLIC NOTICE:**

A notice regarding the subject amendment was sent to all parties of record by the Applicant on March 17, 2011. The notice gave interested parties 15 days to review and comment on the amended site plan per Montgomery County Zoning Ordinance Section 59-D-3.7. Staff received no inquiries regarding the proposed amendment.

#### STAFF RECOMMENDATION:

Site conditions during development necessitated the need to make minor alterations from the original approved site plan, including the addition of a retaining wall needed to complete the sidewalk installation for pedestrian connectivity, and to meet current ADA requirements. The bike trail realignment and striping changes were administered by the Department of Permitting Services and the Department of Transportation, while completing their final inspection and bond release walkthroughs.

The proposed modifications to the site plan will not alter the overall character or impact of the development with respect to the original findings of approval. The proposed modifications are necessitated by development challenges and operational considerations to the project. Further, these modifications will not affect the compatibility of the development with respect to the surrounding neighborhood. Staff recommends approval of Site Plan Amendment 82003011C.
