At the time this Staff Report was posted, Staff was not aware of any correspondence from residents or adjacent property owners on the proposal. After the Staff Report was posted, Staff was contacted by a resident of the community via telephone and electronic mail indicating that he had written a letter and mailed it to the Montgomery County Planning Department near the end of January, 2014 opposing the proposed permanent facilities. Staff has not been able locate this letter, but a copy was provided to Staff on August 25th. The following day, Staff received another email in opposition to the proposed permanent facilities (see letter and emails – Attachment A).

Community Concerns

Restrooms

The community residents who wrote in are concerned that the proposed facilities will be a visual irritant to the nearby residences, will attract vagrants, and will invite graffiti and possibly other vandalism.

Noticing


One community member is concerned that the Applicant did not properly notice the community regarding the proposed facilities. At the time the application was filed, the Applicant submitted a copy of: the Notice of Pre-Submission Meeting with the community; an Affidavit of the Pre-Submission Meeting and a copy of the meeting minutes; the Notice of Application; and the confronting and adjoining property owners and interested parties list as required (see Attachment B).

To Whom It May Concern:

We oppose construction of two restrooms by the Montgomery Village Foundation (MVF) in South Valley Park, Montgomery Village. We particularly oppose the inclusion of a restroom that has been proposed to be constructed adjacent to the Park's Lawn Theater, which is very close to numerous residences including our own. We oppose construction for substantive and procedural reasons, as detailed below.

Substantive Objections

The MVF has applied to construct two restrooms in South Valley Park, one near the ballfield and one near the Lawn Theater. Local residents have long opposed such construction, and were surprised to learn recently of the second proposed restroom.

The MVF has stated that the second restroom would only be open when the Lawn Theater operates (about 15 evenings and a few mornings per summer). Of course, in practice the structure would be present year-round. It would be a visual (and likely olfactory) irritant to a large number of nearby residences (both townhouses and condominiums). Moreover, it would present an "attractive nuisance," and likely invite graffiti and possibly other vandalism.

Meanwhile, it is well known that each Lawn Theater event draws only a modest audience. It is not clear why a permanent restroom should be constructed for very occasional seasonal use by a handful of individuals.

Procedural Objections

(1) The MVF held a pre-submission meeting on July 9, 2013. The community closest to both proposed restrooms is Heron's Cove Condominium (400+ residential units). No notice was provided to individual owners or residents in this community (even though the MVF possesses current data for use in mailing annual MVF electoral ballots). Further, the two notices sent to the Association (rather than to individual owners) were incorrectly submitted: one was sent to a

- prior member of the condominium Board who has been deceased for four years, and the other to an off-site manager who has not been associated with Heron's Cove for over five years.
- (2) After the MVF submitted its Development application in early October, 2013, it again failed to mail notice of the application to residents of Heron's Cove, and again only sent notice to the deceased prior Board member and to the long-departed off-site manager.
- (3) One of us personally attended the session held on July 9, 2013, and was assured that "everyone who signs in will receive notice of the formal application." The name and address appear explicitly on the sign-in sheet, as submitted by the MVF in its application. Nevertheless, we did not receive notice of the application (and it appears that at least ten other meeting attendees also were not provided with notice of the application).

WE DO NOT NEED ANYMORE PERMANENT FACILITIES THERE!


We already have problems with vagrants and this will only multiply the problem by giving them another "place" to "go" and hide.

L. Presentation by Benning and Associates on Proposed Site Plan for South Valley Park Restrooms/Concession Stand

The meeting began at 7:31 p.m. Mr. McKee presented the site plan for the South Valley Park Restrooms/Concession Stand. He showed the locations of the two facilities on the plan. It was noted that the concession stand with connected restrooms would be next to the ballfield and would be about 20° x 60° in size. The unisex single use restroom would be adjacent to the music pavillion and would be approximately 12° x 13° in size. MVF would be responsible for maintenance of the restrooms, and the restrooms would be open when there were scheduled activities at the park. A question was asked whether the restroom near the music pavilion would block the view of the fountain in the pond. It was established that the building would not block the view of the fountain.

A meeting attendee suggested that the restroom near the music pavilion be located on the opposite side of the music pavilion or closer to the stage area so that it would not be near the

playground or in view of the Heron's Cove Condominium units. Another attendee suggested to build only the concession stand / restroom facility near the ballfield, and after a few years of observation, decide whether or not to build the additional restroom near the music pavillion. He noted that the restroom near the music pavilion would only really be used during the summer.

Another attendee noted that currently, elderly visitors to South Valley Park often have difficulties getting to the Port-O-Johns.

Another attendee noted that the playground already attracts loud teenagers at all hours of the night, who disrupt the atmosphere of the neighborhood, and it was suggested that the presence of these facilities might attract more unwanted attention in the evenings.

II. Public Comments

Mr. Jacobs expressed the belief that it is good to have the two separate restrooms. Having a restroom by the lawn theater, he said, would be good especially for elderly residents who currently struggle to get to the restroom area.

Ms. Weinberg expressed general agreement with the building of a restroom facility. She asked if there had been any vandalism in the area already. It was noted that there has been graffiti in the past but not recently, and there has been no more vandalism in this location than in any other similar location.

Mr. Okin noted that having a real restroom facility would go a long way toward making the music pavillion look like a professional performance area.

Ms. Peterson expressed a favorable view of the project.

Ms. Haughney strongly suggested moving the small bathroom to the other side of the stage. She lives near the near the music pavilion and she does not want to see a bathroom every time she looks out the window. She expressed the view that such a restroom is unnecessary. She also suggested that the elementary school donate the use of their restrooms for the area. It was established that the school has not agreed to the use of their restrooms for this purpose. It was further established that this would be a security risk for the school, as well as for young athletes using the school restrooms without supervision.

Ms. Wilder suggested merely upgrading the Port-O-Johns to a fancier version of a portable restroom that could be brought in for concerts and removed afterwards. In response to her question about storm water management, it was noted that this building will have more comprehensive storm water management than any other building of its nature in Montgomery

Village because of the new regulations this building must conform to. She questioned the maintenance costs of the new facilities, as well as the security measures that will be taken to protect residents from any negative security side effects of the new facilities. It was noted that there are already people paid to maintain that area, as far as both cleanliness and security. The responsibilities associated with these facilities will be handed to current maintenance and security staff. She suggested putting signage on the fence around the music pavilion area that it is not a dog park.

Mr. Jackson explained that it is difficult for the local football program to compete with neighboring programs, because of Montgomery Village's inferior facilities. He expressed the belief that while the restrooms may be considered by some to be an eyesore, it would be an upgrade from the porta-johns and be helpful to attendees who currently struggle with the present restroom facilities.

Mr. Podolsky noted that there may be unintended consequences of building these facilities, and suggested that the Board try thinking one step ahead to any potential unwanted consequences of these structures.

One attendee wondered if the buildings could be broken into. It was noted that these facilities would be patrolled by security.

III. Adjournment of Meeting

It was established that residents will be alerted to new developments regarding the site via mail. The meeting was adjourned at 8:17 p.m.

The reports, authorizations and other documents presented at the meeting have been initialed for identification and attached hereto or filed in the office of the Montgomery Village Foundation.
