

Summary

Staff Recommendation: Approval of the extension request

Section 59.7.3.4.C provides a 120-day time limit for site plan hearings. The Planning Director may postpone the public hearing by up to 30 days once without the Planning Board approval. On April 4, 2016, the Planning Director approved an extension for the site plan from its originally scheduled public hearing of June 30, 2016 to July 28, 2016. The Sketch Plan Amendment was accepted on April 29, 2016, and also scheduled for a public hearing on July 28, 2016. The Applicant may request a site plan extension beyond the original 30 days with Planning Board approval. In a letter dated June 8, 2016, the Applicant has requested an extension of additional time for the site plan and the sketch plan amendment to address issues raised by staff and to resubmit updated site plans to staff. The Applicant has requested a Planning Board date of September 22, 2016.

Staff recommends approval of this extension request.
