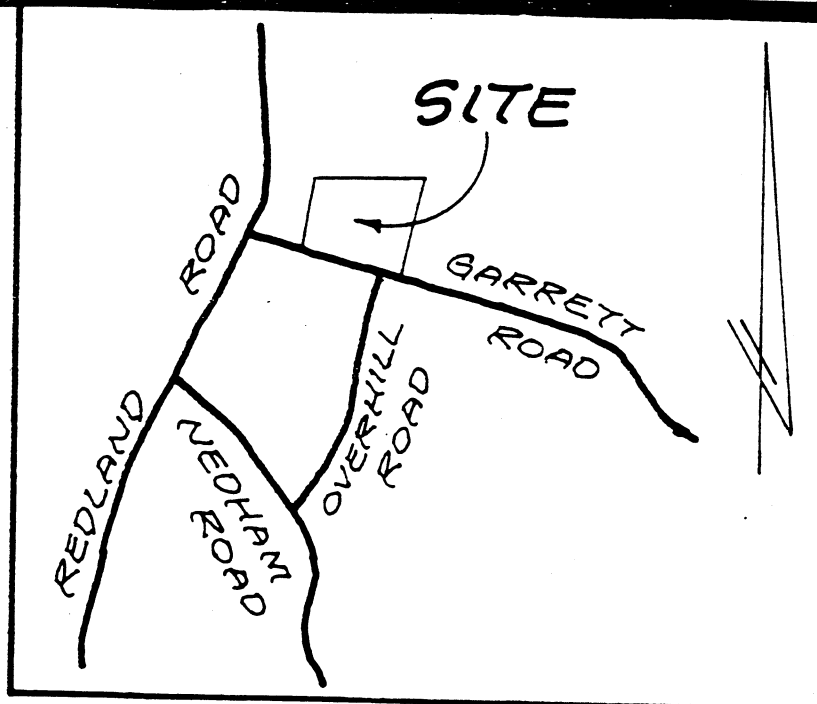

SCALE: 1" = 1,200'

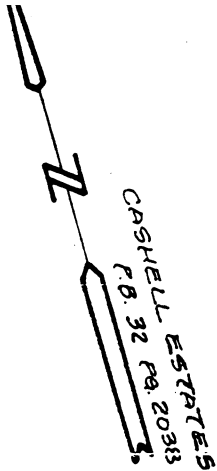
CERTIFICATION

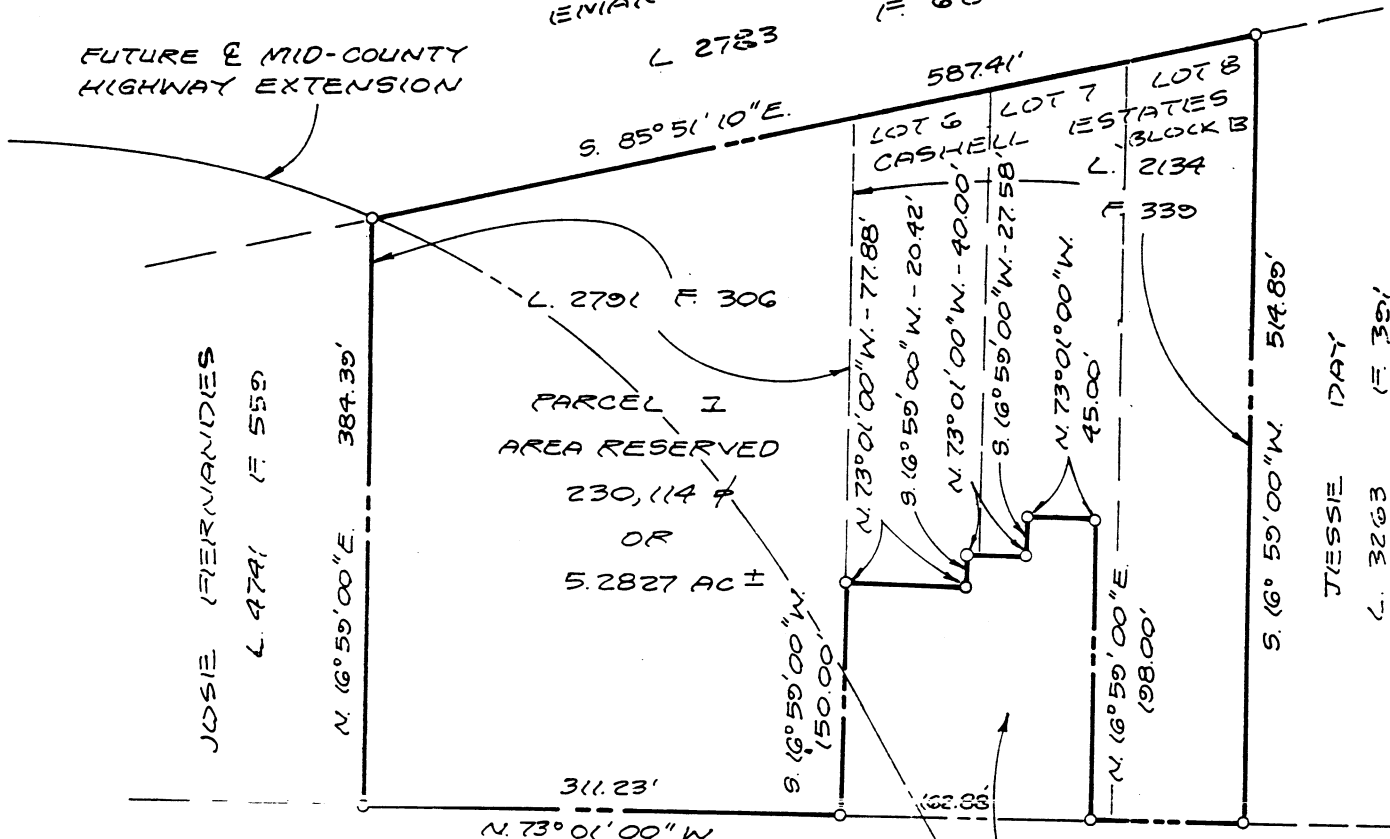
