Location: On Burdette Road, approximately 500 feet



### Summary

Chapter 50, Subdivision Regulations, Section 50.6.3.B.3. provides a 90-day limit for review of Administrative Subdivision Plans. The Planning Director may extend the review period once, while the Planning Board may extend this period further. Consistent with this provision, on September 14, 2017, the Planning Director extended the review from October 5, 2017, to November 9, 2017. The Applicant has requested, in an application dated October 13, 2017, that the review period for the Administrative Preliminary Plan be further extended from November 9, 2017, to December 7, 2017. The extensions will allow the Applicant more time for agency coordination to resolve DRC comments.

Staff recommends **APPROVAL** of the extension request.
