

Description

Request to extend the Sketch Plan and Preliminary Plan Amendment from January 11, 2018 to February 1, 2018.

Location: On Edgemoor Lane at the corner of Woodmont Avenue Zone: CR 2.5 CO.25 R2.5 H90 and CR 2.5 CO.5 R2.5 H150 Master Plan: 2017 *Bethesda Downtown Sector Plan* Property size: 1.65 gross acres Applicant: Equity Residential Acceptance Date: August 28, 2017



Summary

Zoning Ordinance Section 59.7.3.3.C provides a 90-day limit for sketch plan hearings. The Planning Board may, however, extend this period. Chapter 50, Subdivision Regulations, Section 50.4.1.E provides a 120-day limit for preliminary plan hearings. The Planning Board may, however, extend this period. The Applicant requested, in an application dated December 27, 2017, that the review period for both the Sketch Plan and Preliminary Plan Amendment be extended, from the current date of January 11, 2018 to February 1, 2018. The extensions will allow the Applicant more time to address DRC comments and for a joint hearing of the applications, which will be more efficient. The Planning Board hearing on the applications may take place before the end of the review period, and will be publicly noticed in accordance with the Zoning Ordinance. This is the second extension request associated with the subject project.

Staff recommends **APPROVAL** of the extension request.
