
#### Description

#### Old Angler's Cove: Preliminary Plan No 120170290:

Request to extend the regulatory review period by approximately 5 months to November 1, 2018; to subdivide the Subject Property initially proposed for four (4) lots for four (4) detached single-family houses, located on MacArthur Boulevard approximately 2,475 feet west of Brickyard Road; 1.865 acres, R-200; 2002 Potomac Subregion Master Plan.

**Submittal Date:** September 21, 2017 **Review Basis:** Chapter 22A, Chapter 50



#### Summary

Section 50.4.1.E of the Subdivision Regulations establishes the review procedures for a Preliminary Plan application and states that:

"the Board must schedule a public hearing to begin within 120 days after the date the Director accepts an application. The Director may postpone the public hearing by up to 30 days once without Board approval. The Director or applicant may request one or more extensions beyond the original 30 days with Board approval. The Board must notice the public hearing and indicate the new hearing date on the Board's agenda. An application that was filled before February 13, 2017 is not subject to the subsection."

The Old Angler's Cove Preliminary Plan application was accepted on September 21, 2018, which established a Planning Board date no later than February 8, 2018. The Planning Director previously approved an extension to March 8, 2018. On January 9<sup>th</sup>, 2018, the Planning Board approved an extension to June 8, 2018. Unfortunately, the resubmittal of these plans during this extension period was unacceptable for making legal findings necessary to approve a preliminary plan. While the Applicant's requests an extension to October 2, 2018, Staff is concerned that this amount of time is insufficient to bring this application to the Planning Board for consideration. The additional time will allow the Applicant to focus on the revisions necessary to make legal findings and for staff review and package the application for a public hearing. Therefore, Staff is recommending an extension to November 1, 2018.

Staff recommends approval of this extension request.
