

## Staff Report Date: 9/14/18

## Description

- A. First National Bank Germantown: Preliminary Plan Amendment No. 11985200A: Request to extend the regulatory review period for an additional two months until November 27, 2018; Application to replace an existing restaurant use with a 3,270 square foot bank with a drive-thru; 0.70 acres; GR-1.5 H-45 Zone; located on the southwest quadrant of the intersection of Germantown Road and Crystal Rock Drive; 2009 Germantown Employment Area Sector Plan.
- B. First National Bank Germantown: Site Plan No. 820180140: Request to extend the regulatory review period for an additional two months until November 27, 2018; application to replace an existing Pizza Hut restaurant with a 3,270 square foot bank with a drive-thru; 0.70 acres; GR-1.5 H-45 Zone; located on the southwest quadrant of the intersection of Germantown Road and Crystal Rock Drive; 2009 Germantown Employment Area Sector Plan.

#### Summary

Section 50.4.1.E of the Subdivision Regulations and Section 59.7.3.4.C of the Montgomery County Zoning Ordinance provides that the Planning Board shall hold a public hearing for Preliminary and Site Plans no later than 120 days after the date the application(s) are accepted. However, the Director may postpone the public hearing by up to 30 days once without Board approval and the Director or applicant may request one or more extensions beyond the original 30 days with Board approval.

The First National Bank Preliminary Plan Amendment and the Site Plan applications were accepted on May 22, 2018, which established a Planning Board date no later than September 27, 2018. The Applicant is requesting an additional two-month extension to allow for sufficient time to respond to comments received from the Development Review Committee and Staff, and to finalize plans (Attachment A). Granting the extension establishes a Planning Board date no later than November 27, 2018.

Staff recommends **approval** of this extension request.
