
Description

Pleasant Grove Community Church: Site Plan No.820190010:

Request to extend the regulatory review period for Site Plan No. 820190010 from 1/24/2019 until 5/9/2019: An Application for the construction of an 8,600 square foot religious institution; located 700 feet west of Johnson Drive; 4.02 acres; R-200 zone; 2006 Damascus Master Plan.

Applicant: Reverend Lawrence Bryant

Acceptance date: 8/29/2018 Review Basis: Chapter 59



Chapter 59 of the Montgomery County Zoning Ordinance, Section 59.7.3.4.C, provides that the Planning Board shall hold a public hearing for Preliminary and Site Plans no later than 120 days after the date the application(s) are accepted. However, the Director may postpone the public hearing by up to 30 days once without Board approval and the Director or applicant may request one or more extensions beyond the original 30 days with Board approval.

Site Plan No. 820190010 was accepted on August 29, 2018, which established a Planning Board date no later than December 27, 2018. The Director granted a 30 day extension which established a Planning Board date no later than January 26, 2019. The Applicant is requesting a 2nd extension, for 102 days in order to adequately address agency comments and complete additional survey work (Attachment 1). Granting the extension establishes a Planning Board date no later than Thursday, May 9, 2019.

Staff recommends approval of this extension request.
