Conditional Use - Chapter 59



- Section 50.4.1.E. of the Subdivision Regulations states that the Board must schedule a public hearing to begin within 120 days after the date an application is accepted. The Director may postpone the public hearing once, by up to 30 days, without Board approval.
- The Application was accepted on April 29, 2025, with an original 120-day regulatory review period expiration of August 27, 2025.
- The Applicant is requesting a three-month extension of the regulatory review period, which requires Planning Board approval. The regulatory extension, from August 27, 2025 to November 27, 2025, is requested to allow the Applicant to continue coordination, address agency comments and provide a traffic study.
- Staff supports the Applicant's request to extend the review period with a tentative Planning Board date of October 30, 2025.
