# Description

Request to extend the regulatory review period for the Loehmann's Plaza Preliminary, Site, and Forest Conversation Plans for ten (10) additional weeks, from August 29, 2024, through November 7, 2024. The Application seeks to implement infill development with up to 710,000 square feet of residential uses and up to 40,000 square feet of commercial uses for a cumulative density of up to 750,000 square feet of total development, with 15% Moderately Priced Dwelling Units (MPDUs), open space, pedestrian and bicycle improvements, and associated public benefits to support incentive density. The Site is an existing shopping center on 9.74-acres of land zoned Commercial Residential (CR–1.75, C–0.5, R–1.5, H–75).

# **Summary**

- Section 59.7.3.C of the Zoning Ordinance provides a 120day review period for Site Plan hearings. The Planning Board may, however, extend this period.
- This is the first extension request associated with the Applications that were jointly submitted.
- The Applicant has requested, in an application dated July 18, 2024, that the review period for the Preliminary, Site, and Forest Conservation Plans be extended by ten (10) weeks from August 29, 2024 to November 7, 2024.
- This extension will allow the Applicant to continue to work with Planning Staff and the Montgomery County Department of Transportation (MCDOT), to adequately address a variety of Development Review Committee (DRC) comments.
- Key issues that require additional agency coordination include: (1) refinement of proposed roads and bicycle facilities; (2) refinement of the proposed public benefit points for incentive density; (3) requirements for open space; and (4) phasing.
- Staff recommends APPROVAL of the extension request through November 7, 2024.
- The Planning Board hearing on the application may take place before the end of the review period, with a tentative Planning Board date of November 7, 2024, and will be publicly noticed in accordance with the Zoning Ordinance.
