The purpose of the Silver Spring Placemaking is to frame place identity opportunities and challenges related to current issues, while building on the Silver Spring Sector Plan from 2000.





### 2000 Silver Spring Sector Plan

The current Silver Spring Sector Plan was last updated in 2000. Since then, many aspects of the plan have been implemented to transform Downtown Silver Spring into a vibrant urban community.



# Background

### 2010 Greenspace Plan



The Greenspace Plan's Guidelines identify potential sites that could provide large, landscaped public spaces and outline design principles for how to develop them.

### 2012 Parks, Recreation + Open Space Plan (PROS)

The 2012 PROS Plan focuses on locating the right park and recreation facilities in the right places, to ultimately help ensure that the parks and recreation system continues to play a major role in shaping Montgomery County's high quality of life. PROS includes service delivery strategies for several park amenities, from civic greens to dog parks, based on population densities and existing distribution of facilities. Downtown Silver Spring is in the area of the County with the lowest amount of park and recreation services per population.




