

Description

- Request to extend the review period for a site plan from to July 21, 2016 to September 21, 2016;
- Located at 8015 Old Georgetown Road, at the corner of Glenbrook Road;
- 2.00 gross acres zoned PD-44 in the Woodmont Triangle Amendment to the Bethesda CBD Sector Plan area;
- Applicant: Bush at 8015 Old Georgetown Road Associates, LLLP;
- Application Acceptance date: March 9, 2016.



Summary

Section 7.3.4.C of the Zoning Ordinance provides that the Planning Board shall hold a public hearing no later than 120 days after the filing of a Site Plan. The Planning Board may, however, extend this period. The Applicant has requested an extension for additional time to address issues raised at the Development Review Committee, to coordinate with review agencies, and to resubmit updated plans to all agencies. The Application was granted a 30-day extension by the Planning Director, on April 22, 2016, extending the review period from July 14, 2016 to July 22, 2016. The Applicant has requested, in a letter dated June 9, 2016, that the review period for the Site Plan be extended until September 21, 2015 by the Planning Board.

Staff recommends **APPROVAL** of the extension request.
