

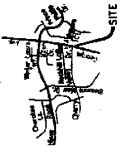
SOUTH ELEVATION

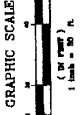


VICINITY MAP

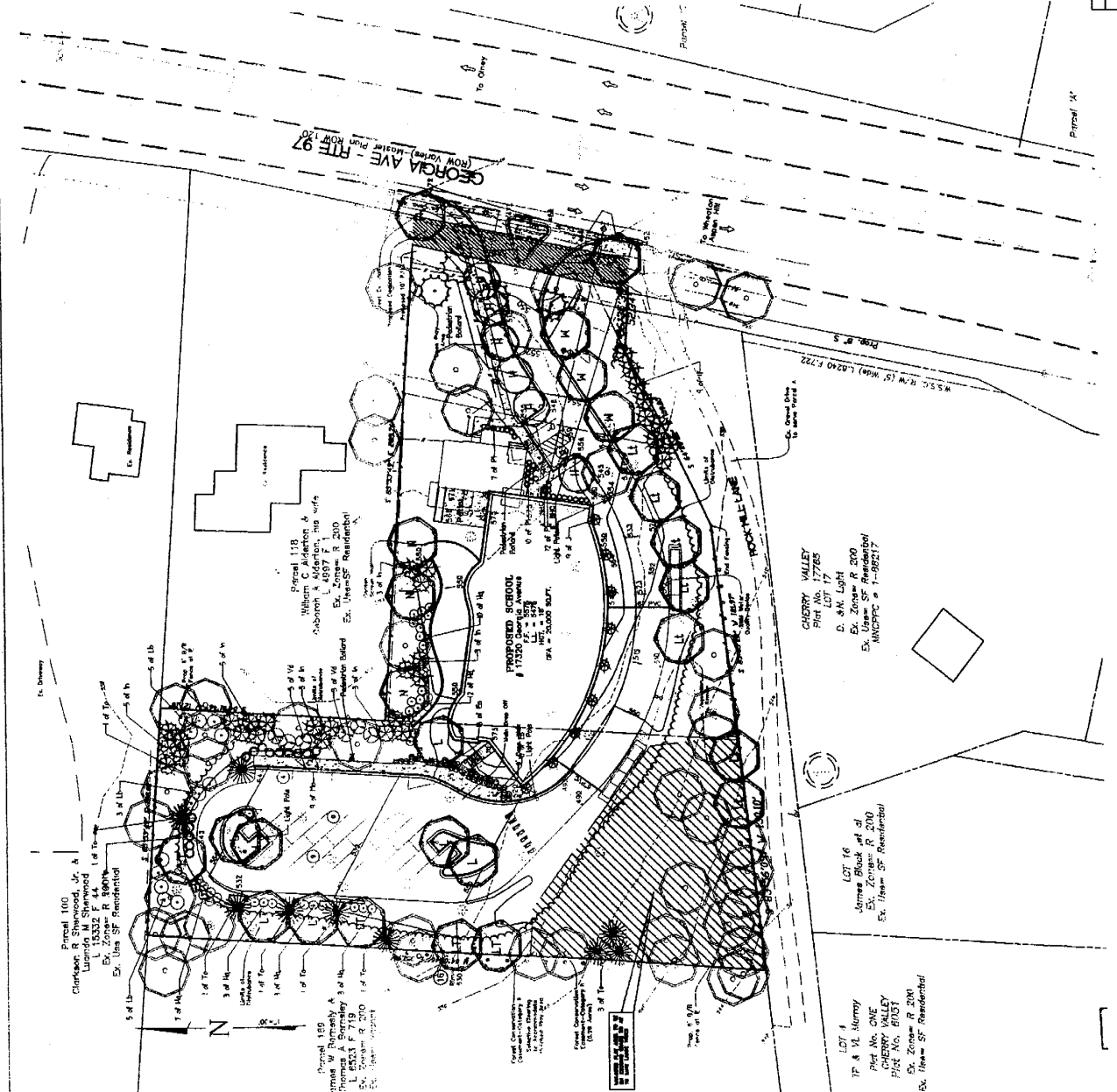
