

## Description

Request to extend the regulatory review period for Site Plan No. 820150140 an additional 4 months.

- Residential development consisting of 6 townhouse units on 0.5 acres of land zoned RT-12.5;
- Located on Hillery Way approximately 450 feet west of Rockville Pike (MD 355) within the 2010 White Flint Sector Plan area;
- Application Accepted: May 3, 2016;
- Applicant: Alexander & Miry Livnat;
- Review Basis: Chapter 59, Montgomery County Code.



### Summary

Section 59-7.3.4.C of the Zoning Ordinance generally states that a Site Plan application must be scheduled for a public hearing within 120 days after the date an application is accepted. The Site Plan Application was accepted on May 3, 2016, with a tentative Planning Board date of September 8, 2016. The Applicant has made several timely requests for extensions, which were all subsequently approved by the Planning Board.

The Applicant is now seeking a four-month extension to allow the Applicant's team additional time for revisions and continued coordination with Staff and other County agencies.

Staff recommends approval of the proposed extension request, which sets a Planning Board date on April 5, 2018.
