RESOLUTION

WHEREAS, under Montgomery County Code Chapter 19, Article V, water quality review in Special Protection Areas must be done in conjunction with the review of a development plan, diagrammatic plan, schematic development plan, project plan, preliminary plan of subdivision, site plan, mandatory referral, or special exception; and

WHEREAS, to avoid duplication of effort, the Montgomery County Department of Transportation ("DPS") and the Montgomery County Planning Board each have responsibility for review and approval of different elements of water quality plan applications; and

WHEREAS, the Planning Board is responsible to review water quality plan applications to determine if environmental buffer protection, forest conservation and planting requirements, and site impervious limits have been satisfied; and

WHEREAS, in cooperation with DPS' review and approval of those elements of the water quality plan for which DPS is authorized, the Planning Board is authorized to take final action on the water quality plan; and

WHEREAS, on February 16, 2018, Montgomery County Department of Transportation ("Applicant") filed an application for approval of a water quality plan for road improvements on approximately 5.94 acres along Clarksburg Road generally located at the intersection of Snowden Farm Parkway in Clarksburg ("Subject Property") in the Clarksburg Special Protection Area ("SPA") within the Clarksburg Master Plan ("Master Plan") area; and

WHEREAS, Applicant's water quality plan application was designated Water Quality Plan No. MR2018018, Clarksburg Road at Snowden Farm Parkway ("Preliminary/Final Water Quality Plan" or "Application"); and

WHEREAS, following review and analysis of the Application by Planning Board staff ("Staff") and other governmental agencies, Staff issued a memorandum to the Planning Board dated March 29, 2018, setting forth its analysis and recommendation for approval of the Application, subject to certain conditions ("Staff Report"); and

WHEREAS, the Staff Report included a copy of a letter dated December 8, 2017 from DPS conditionally approving the elements of the Preliminary/Final Water Quality Plan under its purview; and

WHEREAS, on April 12, 2018, the Planning Board held a public hearing on the Application at which it heard testimony and received evidence submitted for the record on the Application; and

WHEREAS, at the hearing, the Planning Board voted to approve the Application subject to certain conditions, by the vote certified below.

NOW, THEREFORE, BE IT RESOLVED that the Planning Board APPROVES Preliminary/Final Water Quality Plan No. MR2018018, Clarksburg Road at Snowden Farm Parkway on the Subject Property, subject to the following conditions:¹

- 1. The impervious surfaces are limited to the area as shown on the Impervious Surface Plan Portion of the Preliminary/Final Water Quality Plan. Impervious surfaces should be limited to no more than 28%.
- 2. Applicant shall mitigate forest losses on a 1:1 basis according to the approved forest conservation exemption and tree save plan.
- Prior to the start of any clearing, grading, or demolition, the Applicant must have an approved forest conservation exemption and tree save plan that matches the final road improvement design.

BE IT FURTHER RESOLVED that having given full consideration to the recommendations and findings of its Staff as presented at the hearing and as set forth in the Staff Report, which the Board hereby adopts and incorporates by reference (except as modified herein), and upon consideration of the entire record, the Montgomery County Planning Board FINDS, with the conditions of approval, that:

The Application satisfies all the applicable requirements of Montgomery County Code, Chapter 19, Article V – Water Quality Review in Special Protection Areas.

<u>Conformance with Environmental Guidelines</u>: The project proposes no forest removal, no impacts to the Stream Valley Buffer (SVB), and no impacts to the 100-Year-Floodplain. There are no direct environmental impacts associated with the Clarksburg Road project.

¹ For the purpose of these conditions, the term "Applicant" shall also mean the developer, the owner or any successor(s) in interest to the terms of this approval.

<u>Impervious Surfaces</u>: Within the Clarksburg SPA there is no impervious surface cap or limit, but the project must minimize impervious surfaces to the amount needed to achieve the public purpose intended.

The area of the project within the SPA is approximately 5.94 acres and currently has .55 acres of imperviousness or 9%. The proposed roadway improvements will add an additional 1.19 acres of imperviousness and remove 0.05 acres for a total of 1.69 acres or 28%. The road improvements are being built to current standards and there are no unnecessary impervious surfaces.

The Application met applicable requirements for environmental buffer protection, forest conservation. As conditioned by this approval, site impervious limits have been satisfied. Therefore, the Application satisfies all the elements of the Preliminary/Final Water Quality Plan under the Board's purview.

The stormwater management plan, sediment and erosion control plan, and the water quality monitoring component have been reviewed and conditionally approved by DPS, in coordination with the Montgomery County Department of Environmental Protection, as the lead agencies for these components of the Water Quality Plan review. Therefore, the Application satisfies all the elements of the Preliminary/Final Water Quality Plan under DPS' purview.

BE IT FURTHER RESOLVED that this Resolution incorporates by reference all evidence of record, including maps, drawings, memoranda, correspondence, and other information; and

BE IT FURTHER RESOLVED that this Resolution constitutes the written opinion of the Board in this matter, and the date of this Resolution is _____APR 1 8 2018 (which is the date that this Resolution is mailed to all parties of record); and

BE IT FURTHER RESOLVED that any party authorized by law to take an administrative appeal must initiate such an appeal within thirty days of the date of this
