

## Description

Request to extend the regulatory review period for Preliminary Plan No. 11989271C and Site Plan No. 82008024B, from September 6, 2018 to October 25, 2018.

Location: 10401 Old Georgetown Road (MD 187), approximately 100 feet south of intersection of Rock Spring Drive; Master Plan: 2017 *Rock Spring Sector Plan;* Zone: CRT-1.25: C-0.5, R-0.75, H-50; Property Size: 3.49 acres; Application Accepted: April 5, 2018; Applicant: Alvin Aubinoe, Wildwood Medical Center; Review Basis: Chapter 50, Subdivision Regulations

and Chapter 59, Zoning Ordinance.



## Summary

Section 50-4.1.E of the Subdivision Regulations and Section 59-7.3.4.C of the Zoning Ordinance generally states that Preliminary Plan and Site Plan applications must be scheduled for a public hearing within 120 days after the date an application is accepted.

The Application was accepted on April 5, 2018, with a tentative Planning Board date of August 2, 2018. On May 16, 2018, the Applicant made a timely request for just over one month, which exceeds the 30-day extension that can be granted by the Planning Director; therefore, it required Planning Board approval. The Planning Board granted the extension on June 14, 2018. The revised tentative Planning Board date was set for September 6, 2018.

The Applicant is requesting a second extension for two months for the Preliminary Plan and Site Plan review periods from September 6, 2018 to October 25, 2018, because additional time is required to address the Planning Department and external agency comments.

Staff supports the Applicant's request to extend the review period with a tentative Planning Board date of October 25, 2018.
