

Summary

Section 50.4.1.E provides a 120-day review period for Preliminary Plan hearings. The Planning Board may, however, extend this period. The Applicant has requested, in an application dated February 6, 2019, and accompanying letter dated February 13, 2019, that the review period for the Preliminary Plan be extended from the current date of March 28, 2019, to September 28, 2019, to allow the Applicant time to investigate and evaluate potential plan revision alternatives. The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance. This is the first extension request associated with the subject project.
