**Description**

**Avalon Residential: Site Plan No. 820190070,  
Regulatory Review Extension Request No. 2**

Request to extend the regulatory review period by 3 months to July 13, 2019; to construct 16 attached single family and 34 detached single family dwelling units, including 16% MPDUs (8 units); located at 22821 Frederick Road, approximately 600 feet north of the intersection of Frederick Road (MD 355) and Shawnee Lane; identified as parcels P765, P770, and P801 on Tax Map EW41; 10.28 acres; TF-5 zone; 1994 *Clarksburg Master Plan & Hyattstown Special Study Area*.



**Summary**

Section 59.7.3.4.C of the Montgomery County Zoning Ordinance provides that the Planning Board shall hold a public hearing for Site Plans no later than 120 days after the date the application(s) are accepted. However, the Director may postpone the public hearing by up to 30 days once without Board approval and the Director or applicant may request one or more extensions beyond the original 30 days with Board approval.

The Avalon Residential Site Plan application was accepted on November 13, 2018, which established a Planning Board date no later than March 13th, 2019. The Applicant received a 30-day Director level extension to April 13<sup>th</sup>, 2019. The Applicant has addressed significant DRC comments and has just resubmitted plans and documents to meet and address these comments. The delay in the resubmittal requires and extension of the regulatory review period in order to adequately complete the review and prepare staff recommendations. The Applicant requests a 3-month extension to no later than July 13, 2019, with the understanding that the application will be scheduled to the Planning Board at the earliest available time.

Staff recommends **approval** of this extension request.
