Location: 3906 and 3910 Knowles Avenue. Sector Plan: 2012 Kensington Sector Plan.


Zone: CRT-2.5, C-2.0, R-2.0, H-75. Size: 34,597-square foot tract.

#### Summary

Section 50.4.1.E of the Subdivision Regulations and Section 59.7.3.4.C of the Zoning Ordinance provide 120-day limits for the Preliminary Plan and Site Plan hearings, respectively. However, the Planning Board may extend these periods.

The Application was accepted on February 11, 2019, and the Planning Director previously approved a three-week extension request from June 6, 2019 to June 27, 2019.

Due to the Kensington Estates Civic Association not being properly notified, Planning Staff is requesting the Planning Board approve the extension request for 2 weeks, from June 27, 2019 to July 11, 2019 to provide notice.
