Hi Frank,
Thanks for forwarding to me.
We will be starting a multi-year sidewalk improvement project for sidewalks along State roads. It is likely that the section of sidewalk in that block of MD410 (Chicago to Takoma Ave) will be our first project and is expected to take place this summer. Since it is within SHA right of way it requires a District permit and SHA approval.
With regard to widening the road for a bus pull off, that is no longer acceptable to WMATA and Ride On. Buses stop in the travel lane and do not pull off and back on to the main travel lane. While it does slow traffic, it is seen as the safer option. SHA would not likely consider a request to widen the road at the bus stops. Additionally, there is competing information about the width of the right of way along MD410 in that area, with the County GIS showing a 40 foot right of way and SHA a 70 foot one.
