

Description

 Second request to extend review of a subdivision to create one lot.

- Located on the north side of the Easley Street, approximately 300 feet east of Fenton Street.
- 0.17 acres (7,500 square feet)
- CRN 0.5 C 0.5 R 0.25 H-35 zone
- 2000 Silver Spring CBD Sector Plan
- Acceptance Date: October 29, 2019
- Applicant: Red Rock Films, Inc.
- Chapter 50, Chapter 22A



Staff Recommendation: Approval of the extension request.

Section 50.4.1.E of the Subdivision Regulations provides a 120-day limit for preliminary plan hearings. The Planning Board may, however, extend this period. Based on the Application's acceptance date of October 29, 2019 and previous 1-month extension for the Subject Project, the Preliminary Plan review period will expire on March 26, 2020. The first extension request was granted by the Planning Director on January 8, 2020, extending the review period from February 26, 2020 to March 26, 2020.

The Applicant is continuing to address agency comments and requests additional time to coordinate with reviewing agencies. Items that remain outstanding include: a public storm drain connection, compliance with the Silver Spring Streetscape requirements, and documentation of the proposed off-site parking facility. The Applicant therefore requests an additional two-month extension through May 29, 2020. This is the second extension request associated with the subject project.
