

### Summarv

Section 59.7.3.3.C of the Zoning Ordinance and Section 50.4.1.E of the Subdivision Regulations provide a 90-day limit for administrative plan hearings. The Planning Board may, however, extend this period.

The Applicant has requested the review period for the Application be extended through the end of the 2020 calendar year to make lot design changes as requested by Staff and the Development Review Committee. The Application also requires approval by the City of Takoma Park for stormwater and tree removal based on the updated design prior to bringing the application forward for Planning Board consideration. This is the first extension request associated with the Administrative Subdivision Plan application.

Staff recommends **APPROVAL** of the extension request.
