RE: Seven Oaks Traffic Plan

Dear Mr. Gilson:

We are writing to update you on the status of the Seven Oaks Traffic Plan for the area bounded by Colesville Road, Dale Drive, Wayne Avenue and Cedar Street. As you are aware, the plan did receive the required 2/3 majority endorsement -- the final tally was:

Total Yes Ballots Returned - 139  
Total No Ballots Returned - 36  
Total Occupied Households - 206

We have begun the preparatory work necessary to implement the plan and expect to implement it at the end of this month or early February. The restrictions will be initially implemented through signing (in addition, pavement markings and plastic flex posts will be used at Ellsworth Drive and Cedar Street). We can consider actual physical modifications as appropriate in the future once we are very sure that the plan is functioning as the neighborhood wishes.

We are willing to make minor modifications to the plan providing they do not jeopardize its overall integrity. For instance, we could consider removing one of the peak hour turn or one way restrictions that affect only one particular street or block if 2/3 of the residents petition for the removal and we have the endorsement of the citizens association.

We will advise you of the actual implementation date at least one week in advance. If you have any questions, please contact Sarah Navid at 217-2190.

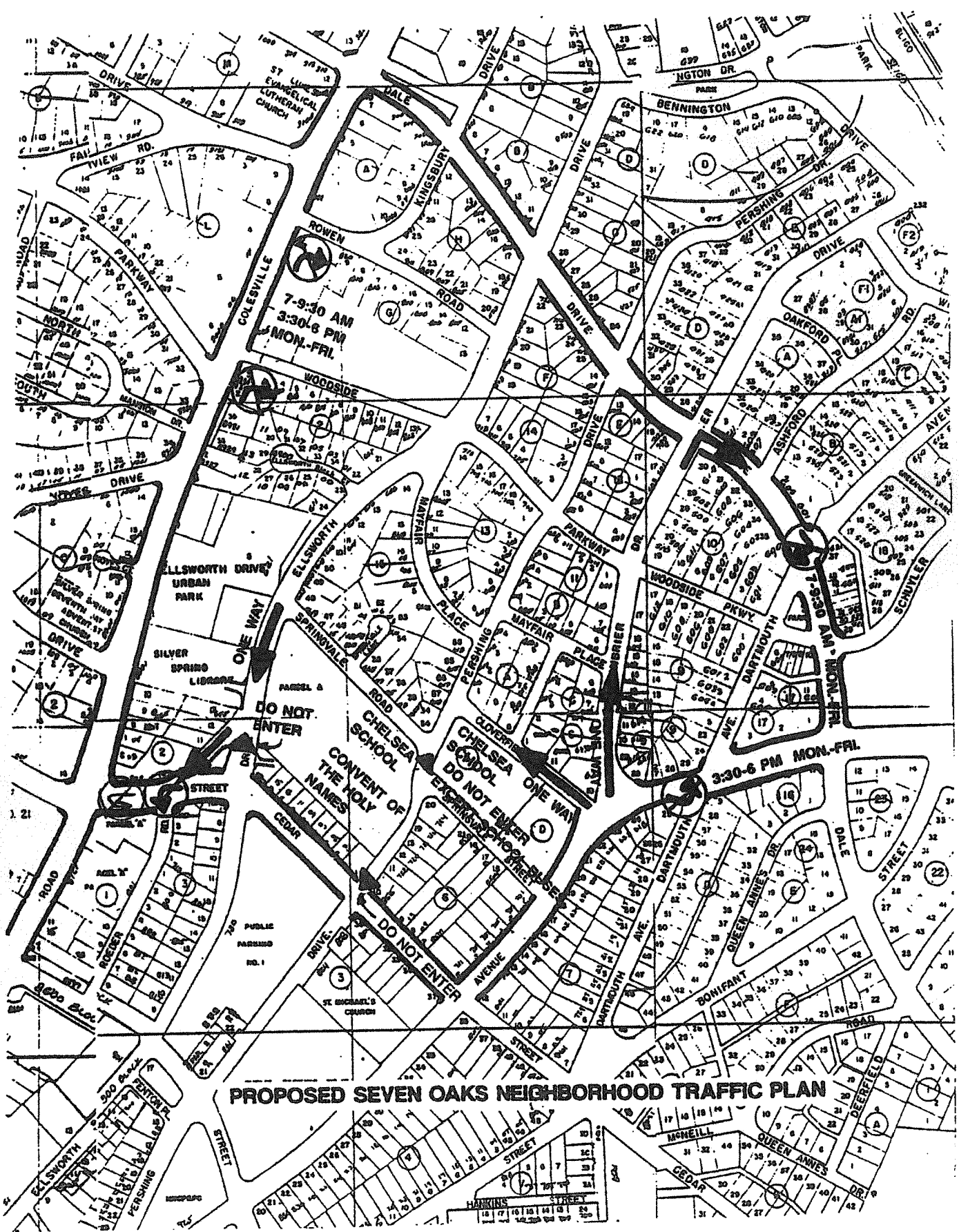

BACKGROUND

A neighborhood through traffic volume management plan for the Seven Oaks neighborhood adjacent to the Silver Spring CBD was developed in conjunction with the Seven Oaks-Evanswood Citizens' Association. A public meeting was held and a neighborhood ballot was conducted.

JUSTIFICATION

The plan received the required two-thirds majority endorsement. The attached traffic orders implement the plan as voted on. The Maryland State Highway Administration is legalizing the restrictions at intersections with Colesville Road (U.S. 29) and Dale Drive (Md. 391).


