RESOLUTION

WHEREAS, under Montgomery County Code Chapter 19, Article V, water quality review in Special Protection Areas must be done in conjunction with the review of a development plan, diagrammatic plan, schematic development plan, project plan, preliminary plan of subdivision, site plan, mandatory referral, or special exception; and

WHEREAS, to avoid duplication of effort, the Montgomery County Department of Transportation ("DPS") and the Montgomery County Planning Board each have responsibility for review and approval of different elements of water quality plan applications; and

WHEREAS, the Planning Board is responsible to review water quality plan applications to determine if environmental buffer protection, forest conservation and planting requirements, and site impervious limits have been satisfied; and

WHEREAS, in cooperation with DPS' review and approval of those elements of the water quality plan for which DPS is authorized, the Planning Board is authorized to take final action on the water quality plan; and

WHEREAS, on May 29, 2020, Montgomery County Department of Transportation ("Applicant") filed an application for approval of a water quality plan for road improvements on approximately 3.04 acres along 4,500 feet of Good Hope Road generally located near the intersection of Briggs Chaney Road in Cloverly ("Subject Property") in the Upper Paint Branch Special Protection Area ("SPA") within the Cloverly Master Plan ("Master Plan") area; and

WHEREAS, Applicant's Water Quality Plan application was designated Water Quality Plan No. MR2020035, Good Hope Road Sidepath ("Preliminary/Final Water Quality Plan" or "Application"); and

WHEREAS, following review and analysis of the Application by Planning Board staff ("Staff") and other governmental agencies, Staff issued a memorandum to the

Planning Board dated September 10, 2020, setting forth its analysis and recommendation for approval of the Application, subject to certain conditions ("Staff Report"); and

WHEREAS, the Staff Report included a copy of a letter dated January 28, 2020 from DPS conditionally approving the elements of the Preliminary/Final Water Quality Plan under its purview; and

WHEREAS, on September 24, 2020, the Planning Board held a public hearing on the Application at which it heard testimony and received evidence submitted for the record on the Application; and

WHEREAS, at the hearing, the Planning Board voted to approve the Application subject to certain conditions, by the vote certified below.

NOW, THEREFORE, BE IT RESOLVED that the Planning Board APPROVES Preliminary/Final Water Quality Plan No. MR2020035, Good Hope Road Sidepath on the Subject Property, subject to the following conditions:¹

- 1. The impervious surfaces are limited to the area as shown on the Impervious Surface Plan portion of the Preliminary/Final Water Quality Plan. Impervious surfaces may be increased if the width of the sidepath is increased to ten-feet.
- 2. Final location of the impervious surface mitigation must be completed prior to the pre-construction meeting.
- Applicant shall provide tree protective measures and tree mitigation according to the approved Tree Save Plan and at the direction of the Forest Conservation Inspector.

BE IT FURTHER RESOLVED that having given full consideration to the recommendations and findings of its Staff as presented at the hearing and as set forth in the Staff Report, which the Board hereby adopts and incorporates by reference (except as modified herein), and upon consideration of the entire record, the Montgomery County Planning Board FINDS, with the conditions of approval, that:

The Application satisfies all the applicable requirements of Montgomery County Code, Chapter 19, Article V – Water Quality Review in Special Protection Areas.

<u>Conformance with Environmental Guidelines</u>: The project proposes disturbance to 0.65 acres of stream, wetland, and other sensitive areas. This is due primarily to the existing stream crossings and the need for some additional disturbance.

¹ For the purpose of these conditions, the term "Applicant" shall also mean the developer, the owner or any successor(s) in interest to the terms of this approval.

Impacts to these areas will be mitigated by making improvements to stormwater management, stream channel restoration, and replacement plantings on Park property.

<u>Forest Conservation</u>: The Applicant met applicable requirement for forest conservation requirements under an approved forest conservation plan exemption and tree-save plan.

<u>Impervious Surfaces</u>: The area of the project within the SPA is approximately 3.74 acres. In addition to the existing roadway approximately 0.75 acres of new impervious surface will be added and approximately 0.13 acres of impervious surface will be removed.

The Applicant has proposed to mitigate the remaining 0.62 acers within the SPA. A finalized plan should be completed prior to the start of the project. County regulations allow reduced width side paths (shared use paths) in environmentally sensitive areas. The side path on Good Hope Road can be reduced from ten feet wide to eight feet wide under these regulations. The improvements are being built to current standards and there are no unnecessary impervious surfaces. The Planning Board believes that the Applicant has minimized the total amount of impervious surface while maintaining the public purpose.

The Application met applicable requirements for environmental buffer protection, forest conservation. As conditioned by this approval, site impervious limits have been satisfied. Therefore, the Application satisfies all the elements of the Preliminary/Final Water Quality Plan under the Board's purview.

The stormwater management plan, sediment and erosion control plan, and the water quality monitoring component have been reviewed and conditionally approved by DPS, in coordination with the Montgomery County Department of Environmental Protection, as the lead agencies for these components of the Water Quality Plan review. Therefore, the Application satisfies all the elements of the Preliminary/Final Water Quality Plan under DPS' purview.

BE IT FURTHER RESOLVED that this Resolution incorporates by reference all evidence of record, including maps, drawings, memoranda, correspondence, and other information; and

BE IT FURTHER RESOLVED that any party authorized by law to take an administrative appeal must initiate such an appeal within thirty days of the date of this Resolution, consistent with the procedural rules for the judicial review of administrative agency decisions in Circuit Court (Rule 7-203, Maryland Rules).
