

## **Description**

- First request to extend review of a concurrent preliminary plan amendment and site plan application to modify a previously approved site access point and construct a residential care facility of up to 155 beds;
- Located in the southern quadrant of the intersection of River Road and present-day Ridgefield Road (future realigned Westbard Avenue);
- 2.92 acres (127,280 square feet) tract area;
- CRT 1.5 C 0.5 R 1.5 H 75' zone;
- 2013 Westbard Sector Plan;
- Accepted: June 17, 2020;
- Applicant: Regency Kensington Bethesda Owner, LLC.



## Staff Recommendation: Approval of the extension request.

Section 50.4.1.E of the Subdivision Regulations and Section 59.7.3.4.C. of the Zoning Ordinance provides a 120-day limit for preliminary plan and site plan hearings, respectively. The Planning Board may, however, extend this period. Based on the Application's acceptance date of June 17, 2020, the preliminary plan and site plan review period will expire on October 15, 2020.

The Applicant has been working with agency staff to address DRC comments, including building architecture, site design, and parkland coordination. In order to adequately address those comments, the Applicant has requested an extension through January 14, 2021. This is the first extension request associated with the subject project.
