Thrive Montgomery 2050 Worksession No. 2: Revised Draft--Section 1: Why we need a new comprehensive plan for the county

Introduction

During the first worksession on December 17, 2020, the Planning Board received an overview of the public comments and highlights of the major issues raised in the verbal and written testimonies. The Planning Board reviewed and approved the revised outline to reorganize the Plan in order to address the public comments and the Board's guidance to make the draft Plan more concise, reduce redundancies, and sharpen its main concepts and the core message. The Planning Board also approved a tentative work program for upcoming worksessions.

The main topic of discussion for today's worksession and approval by the Planning Board is an initial draft of "Section 1--why we need a new plan" (ATTACHMENT 1), which lays out the need for updating the county's General Plan, the context of where we are, and the rationale for Thrive Montgomery 2050's approach to achieve our goals for an economically competitive, equitable, and environmentally resilient place over the next 30 years. Section 1 will replace the first 50 pages of the current Public Hearing Draft including INTRODUCTION, PLANNING CONTEXT, and A PLAN TO THRIVE.

Staff also seeks approval of the schedule and topics of future worksessions. Except for January 14 and 21, all other topics are tentative and may need to be switched around to address the Board's comments or bring back any additional information to the Board for further discussion, as needed.

Starting with worksession 3 on January 14, staff will present a draft chapter (called Theme) based on the revised outline of the Plan at each of the worksessions for Board's approval. In order to let the Planning Board and the public know in advance of what will be discussed at each worksession, an outline of the chapter/theme will be published two weeks in advance of the worksession. This means that the staff packet for every worksession will include: 1) the relevant material for the main topic of the worksession; and 2) an outline of what will be discussed at the following worksession. In addition, staff also intends to publish any relevant material such as a study or analysis, that will be presented to the Board at an upcoming worksession two weeks in advance of that worksession. Therefore, today's packet includes – in addition to the draft of Section 1 – an outline of the main topic of discussion for the January 14 worksession--*Theme #4: Affordable and attainable housing: more of everything,* and a summary of the *Residential Development Capacity Analysis* that was completed as supplemental analysis.
