DEP Staff Report: The applicant has requested approval of sewer category S-1 to allow for public sewer service for the replacement of a single-family home. This property is 2.91 acres in size and zoned RE-2. An existing 8-inch-diameter sewer main runs along The Corral Drive, abutting the property. The county's water and sewer plan policies allow for the provision of public sewer service for properties abutting and predating an existing sewer main. The existing house, built in 1960, was in place when the abutting sewer main was installed in 1994. DEP granted an Advanced Action on December 30th, 2020.

M-NCPPC staff concur that the property is eligible for public sewer service under the abutting mains policy. M-NCPPC Parks confirm there are no park impacts. WSSC confirms that connecting the property to sewer service can be supported. DEP staff recommendation is for the approval of category S-1, for one sewer hookup only, community service for properties abutting mains.

Agency Review Comments

DPS: We have no objection to the category change. This property has no modern septic reserve area. The existing septic system was repaired in 1981.

M-NCPPC – Planning Dept.: This 2.91-acres lot acre is zoned RE-2 and is within the Potomac Sewer envelope of the Potomac Subregion Master Plan. In addition, the property abuts an existing sewer main and is therefore eligible for sewer service under the abutting mains policy.

M-NCPPC - Parks Planning: No park impacts.

WSSC - Water: not requested

WSSC - Sewer: Basin: Rock Run. An existing 8-inch sewer (Contract No. 2001-3161Z) line located in the public road right-of-way of Saunders Court abuts the property. Average wastewater flow from the proposed development: 280 GDP. Interceptor capacity is adequate. Treatment capacity is adequate.

This is to request that WSSC accept and act on an application to provide public sewer service for the following property:

Our records show that the subject property was established by subdivision plat in May 1955, and the existing house was constructed in 1960, prior to construction of the abutting sewer main in 1994. Given this, the property is eligible for a single sewer service connection under the abutting mains service policy in the County's Water and Sewer Plan.

DEP will address the service area category change amendment cited above, which seeks to change the existing S-6 sewer category to S-1, allowing the provision of public sewer service. However, it will take our office some time to process and approve this request, and the owner has indicated a need to expedite the service to this site.

WSSC may install the requested sewer service connection and approve on-site plumbing permits in advance of DEP's approval of the associated service area category change. The County's Water and Sewer Plan allows DEP to direct WSSC to provide public service for cases which clearly satisfy the abutting mains policy (Chapter 1, Section II.G.3.d.).
