## Description

Request to extend the regulatory review period from May 1, 2021 to August 1, 2021; Application to create one lot for a five-story independent senior living facility with up to 111 dwelling units.


**Summary** 

Section 50.4.1.E of the Subdivision Regulations generally states that Preliminary Plans must be scheduled for a public hearing within 120 days after the date an application is accepted.

The Milestone Senior Germantown Preliminary Plan application was accepted on December 2, 2020, which established an approval date no later than April 1, 2021. The Planning Director granted the first extension for a total of 30 additional days or until May 1, 2021. The Applicant needs additional time to secure the necessary approval from DPS SWM. DPS is currently backlogged and has been unable to perform a final review. Therefore, the Applicant requests a 3-month extension or until August 1, 2021.

Staff recommends approval of this extension request.
