Statement of Justification

I am leasing space on the Arcade level of The Promenade Towers. This is an 18 floor high-rise residential condominium building with 1170 units. My office is located on the bottom floor below the Lobby Level. Beneath the Arcade Level is the underground parking providing private residential parking.

The Arcade Level has multiple businesses and amenities. There is a dry cleaners, travel agency, convenience store, salon and restaurant. This is also the floor that has a gym, indoor swimming pool and access to outdoor swimming pool. There are meeting rooms, a Party room and the Administration Office along with medical suites all included on this floor.

I have been a practicing Licensed Massage Therapist at The Promenade since October 1998. I assumed the lease from a prior lease holder in October of 2008.

This space is approximately 170 square feet. There are no plans to makes changes to any structures impacting the number of square feet of this space.

Outside lighting comes from the hallway that my office space is located off of. I have one door off this hallway. This is the only entrance to this space. You must either enter the building through the Arcade or Lobby Levels if visiting the building. Residents just come down to the Arcade Level for appointments. The only signage I use is affixed to this door. It is an oval shape ten inches long by thirteen inches wide that reads "Therapeutic Massage Associates".


Appointments are scheduled in advance. No more than five appointments are scheduled per day. Appointment times can vary in length from thirty minutes to ninety minutes. One hour is the most common length of appointment time.

Hours of operation vary due to a unique scheduling process.

I do not employ any staff.

The majority of clients reside in The Promenade. Some clients do visit the building. The property offers many options for customer/visitor parking; therefore, I do not require any special accommodations for parking availability. There are six customer/guest parking spaces for the Arcade Level and six more on the upper level of open parking. Along with visitor parking there are spaces specific to the salon and medical suites. Being that at the very most, there are times that I would need two spots, one for myself and one for a visiting guest, the guest spot would never be used for more than 90 minutes at a time. The Promenade also provides underground parking for all residents.



The majority of Therapeutic Massage Associates' clients are residents of the Promenade, so parking and traffic are minimally or completely unaffected by these clients. Residents have their own private, underground parking.

For clients who are not residents of the Promenade Towers, the property offers plenty of customer/visitor parking. Thank you for your email. I apologize for the delayed reply. I consulted with Associate County Attorney, Charles Frederick, and Program Manager Victor Salazar about Ms. Mack's case, and we have determined that Ms. Mack's use (massage therapy office) is permitted under a Conditional Use as a Retail/Service Establishment *office* {Sec. 59.8.2.3.B, Footnote 7(c, xii)} in the R-H zone.

Sec. 3.5.11.B.1 defines a Retail/Service Establishment as "a business providing personal services or sale of goods to the public." Additionally, Sec. 3.5.8.B.1 defines an Office as "a room, set of rooms, or a building where the business of a commercial or industrial organization or of a professional person is conducted."

Ms. Mack is a professional person providing personal services in an office. Ms. Mack is licensed by the Maryland Dept. of Health, State Board of Massage Therapy Examiners as a Massage Therapist (License/Registration # M00785)

As authorized under Sec. 2-42B of the Montgomery County Code, it is DPS' interpretation of the code that Ms. Mack may operate her massage therapy office by Conditional Use.
