Dear Ms. Lindsey and Mr. Anderson,

Regarding MHP-Nebel Street Sketch Plan No. 320210110: I feel that it is a poorly conceived and poorly timed project that will destroy needed forest retention areas and exacerbate congestion in an already overcrowded area. The housing units will be directly adjacent to the train tracks and subject to bone-rattling levels of train noise in a low-lying naturally swampy area poorly suited to residential development. The supposed park to be placed in the small triangle of land at the corner of Nebel Street and Old Georgetown Road will only result in the removal of old growth trees and will not create a usable park enviroment worthy of the name. It seems to me that one should consider developing poor quality projects only when land for good quality projects has been fully utilized. The former White Flint Mall space and the space between Marinelli Road and Old Georgetown road uphill from this proposed project represent land much better suited for developent and should be developed before this location is even considered. I should also mention that the "Quad" off of Citadel Avenue currently has three apartment buildings, and the field for the fourth apartment building should also be developed before this proposed area.

I am disappointed in the Planning Board, and do not think that MHP-Nebel Street Plan 320210110 is consistent with the spirit of the White Flint Sector plan to create a high-quality residential and commercial environment. This is not smart development; this is caving in to pressure from developers whose only interest is financial, and who could not care less about the citizens who have to live here.
