

## Summary

Section 50.4.1.E of the Subdivision Regulations generally states that Preliminary Plans must be scheduled for a public hearing within 120 days after the date an application is accepted.

Preliminary Plan No. 120210150 was accepted on March 17, 2021, which established a Planning Board date no later than July 15, 2021. The Director granted a 30-day extension which established a Planning Board date no later than August 15, 2021. The Applicant is requesting a second extension, for four months to complete the Conditional Use process and amend the Preliminary Plan application following approval of the Conditional Use. The Hearing Examiner is currently scheduled to hear the Conditional Use application on July 30, 2021. Granting the extension establishes a Planning Board date no later than December 15, 2021. Staff recommends **approval** of the extension request.
