- Preliminary Plan No. 120210150 was accepted on March 17, 2021, which established a Planning Board date no later than July 15, 2021. The Director granted a 30-day extension which established a Planning Board date no later than August 15, 2021. The Applicant was previously granted a four-month extension until December 15, 2021.
- The Applicant is requesting a 3-month extension to complete the Conditional Use process and amend the Preliminary Plan application following approval of the Conditional Use. Granting the extension establishes a Planning Board date no later than March 10, 2022.
