Dear Planning Board Chair Anderson and Planning Board Members:

This is to convey the very strong support of the Tamarack Triangle Civic Association (TTCA) for the approval of the "Additions to William Tyler Page Elementary School", Mandatory Referral Number: MR2022009.

The TTCA has worked with Montgomery County Public Schools to support this project and actively participated in notifying our community members of MCPS' outreach for virtual community meetings in 2021. We provided community input when reviewing the original three versions of the plans presented and came to a consensus on the final plan as now before the Planning Board.

TTCA has one extenuating concern which we believe that both the Transportation Vehicular Access and Local Area Transportation Review processes have overlooked – especially with the increase in student population projected with the increase in classrooms at the school. This is in the area of both morning and evening traffic congestion and safety caused by school student drop-offs and pickups by parents and school buses. TTCA has received numerous complaints from both residences and parents as to the lack of control of ingress and egress to the student pickup area, the blockage of traffic on Tamarack Road, and of safety concerns regarding traffic movement on Tamarack Road between Northcrest Drive and Canyon Road in both directions. The curve in this section of Tamarack Road presents a significant blind spot and contributes serious safety concerns regarding vehicular movement, and to the morning and after-school congestion caused by traffic. As an aside, TTCA has notified both Montgomery County Department of Transportation and Montgomery County Police Department of this issue in the past year.

In sum, we believe that the proposed additions to WT Page Elementary School will be a model project for the school boundary of this school, and has enthusiastic support by the Tamarack Triangle Civic Association community, a community most directly impacted by this project. We respectfully request that the Planning Board give its approval to this project, with the added provision to find a solution for the vehicular congestion and safety issues mentioned above.
