Dear Chairman Anderson and Members of the Montgomery County Planning Board:

On behalf of our client, NDC Takoma, LLC ("NDC"), the applicant for the abovereferenced Site and Preliminary Plan Applications, we request the Board's approval of the Takoma Junction Site and Preliminary Plans, conditioned upon future State Highway Administration ("SHA") approvals, when this matter is before the Board on January 20, 2022.

When the Site and Preliminary Plan applications were last before the Planning Board on September 15, 2021, the Board was made aware of, and witnessed first-hand, the obfuscatory role the State Highway Administration ("SHA") has been playing in the review of the applications. As detailed in our previous correspondence to you, although the applications were initially submitted on February 14, 2019, SHA did not approve the traffic study for the project for over two years, and did not provide its first design comments until this past April. Since then, NDC and its traffic consultant have been trapped in a continuous cycle of resubmissions to SHA attempting to address their comments and have SHA clarify their concerns.

In an attempt to help facilitate communications and bring the matter to some type of resolution, Chairman Anderson and your Staff intervened and Staff hosted a meeting with NDC and SHA on December 15, 2021. Unfortunately, at this meeting representatives of SHA continued their pattern of avoiding pointed questions and refusing to commit to any position in favor of further delay. For example, instead of directly answering a question regarding whether the removal of vegetation on a neighboring property would resolve their stated sight distance concerns, as NDC's expert traffic consultant believes it should, they remained elusive and stated for the first time that NDC would have to cause the vegetation to be removed, then SHA would re-evaluate the sight distance. We note here that we believe SHA has the authority under state law to remove any vegetation causing a hazard on state roads by seeking an easement for that purpose, and that NDC has asked



the City of Takoma Park to take action to remove the vegetation under its City Code in the attached letter dated December 21, 2021.

Based on this recent meeting, and SHA's insistence on further slow-walking its review of the project, it is clear that NDC will be unable to secure SHA's approval of its proposed access point and lay-by lane prior to the expiration of the latest regulatory review extension on January 20th. Rather than extend the regulatory review timeframe for a sixth time, NDC requests that the Board instead act to approve the Site Plan and Preliminary Plan applications, subject to a condition that NDC must secure SHA's approval of the lay-by lane and proposed access point prior to plan certifications. As detailed in the Staff Report, the sole basis for Staff's recommendation of denial is the lack of these SHA approvals, as all other aspects of the Site and Preliminary Plans conform to the required standards and findings. Thus, conditioning the approval of the Site and Preliminary Plans on SHA's approval of the access and lay-by would address these only deficiencies and allow them to be addressed in due time¹, without further holding up the approval of a project that clearly conforms to the goals and objectives of the County in all other respects.

Thank you for your consideration of this request. We will be available at the hearing on January 20^{th} to address any questions you may have.

¹ In this regard, we note that it is common practice for site and preliminary plan approvals to be conditioned upon future approvals by other agencies. A common condition for projects fronting state roads is that "Applicant must satisfy the provisions for access and improvements as required by Maryland State Highway Administration." Approval of the Site and Preliminary Plans conditioned on future SHA approval of the lay-by lane and site access would be akin to this type of standard condition.

On Wednesday, October 15, 2021, the Montgomery County Planning Board ("MCPB") initiated a video conference call attended by representatives of the Maryland State Highway Administration ("SHA"), representatives of Neighborhood Development Company ("NDC"), and Mr. Cross and Ms. Grigsby on behalf of the City of Takoma Park (the "City"). The purpose of the call was to gain clarity on SHA's position on the proposed layby and site access sight line issues related to the Takoma Junction Project (the "Project").

SHA reiterated during the call that the Project's access point on Carroll Avenue does not meet the AASHTO "Intersection Sight Distance" guideline of 335 feet and that the sight line for cars travelling east on Carroll Avenue, including the current sight line to the entrance of the City Parking Lot, is obstructed by vegetation (trees and shrubs) located on the Healey Building property at 7211 Carroll Avenue, thereby posing a danger to public safety.

While NDC had already committed to negotiate with the owner of the Healey Building for the removal of the trees and shrubs, SHA took the position for the first time during the video conference that it will not measure the site line and consider the waiver request until the obstructions on the Healey property are removed.

We have now learned from the Healey Building owner that he is not willing to speak to us and, therefore, turn to you. We believe the City has the ability to address the vegetation problem as it applies to current traffic conditions and to the Project and we request you do so. City Code \$12.08.030 prohibits any person to permit vegetation on private property "to encroach on,

impede vehicular...passage upon, or to overhang...any street or sidewalk..." The City Manager is authorized to give notice to the owner of such property, and if such person fails or refuses to correct the condition, the City may do so at the expense of the property owner. City Code \$12.08.070(A) and \$12.08.070(B).

Clearly, as shown in the attached photograph and drawings, the existing trees and shrubs are posing a current hazard and should be removed. Please advise us of the City's intentions.

Dear Mr. Anderson: I live one block from Takoma Junction. It is my home away from home. It is already an overwhelming intersection for all concerned -- pedestrians, cyclists, and motorists. It requires two crossing guards to ensure children can cross safely on their way to and from school. And it creates regular bottlenecks on Route 410 and Route 195, also known as Carroll Avenue.

Despite all this, it functions as well as can be expected under the circumstances. But any attempt to intensify its use would push it to the breaking point. At that point, what is merely annoying becomes intolerable. What is merely risky becomes outright dangerous. What is busy becomes hectic and what is full becomes overloaded.

There might have been a time, 25 years ago, when this looked like a sleepy stretch of road. But with the continuing increases in density to the north (Silver Spring), the south (Takoma D.C.) and the West (Hyattsville), those days are long gone.

And so for that reason, I urge you to reject in toto the proposal to develop the public lot at its center.

Dear Casey Anderson,

I am writing about an issue that the Planning Board will address on January 20: Neighborhood Development Corporation's request for provisional approval of a plan to develop a lot in Takoma Park.

As you probably know, the State Highway Administration has found this project unsafe several times and the developer hasn't changed the plan since then. The Takoma Park City Council has rejected this project for at least five significant reasons. In a comment forum open to the public, 96% of comments from the community were against this project. A report by the Board's staff last fall recommended not approving the project. Frankly, we are tired of this unpopular and unsafe project being pushed at a city where a majority of the residents don't want it, by a developer that has violated the terms of existing agreements.

No doubt you have heard from many people about many aspects of the plan. I'd like to address just two. As you have probably heard, the lack of safety is quite obvious to anyone who frequents the intersection as I do several times a week. There are three streets, all crossed by small crowds of school children every day of the school year. Cars speed through to make the light, frequently going through the red. Kids (and grown ups) dash to cross at the end of the walk sign. Cars, even buses, blatantly ignore the crossing guards. As so many have repeated, if the lay-by plan is implemented, it's not a matter if whether there will be accidents, it's a matter of when.

Second is a consideration I haven't heard addressed as much as safety: equity. I've never been against doing *something* with the space under consideration. There are many exciting possibilities! However, the current plan depends on high-end retail shops to survive. Takoma Park has experienced lots of gentrification that is pushing out lower income largely minority people. The new project will not have businesses where lower income people (often minorities here) will feel welcome or be able to shop. Personally, I would prefer that we not sit back and let capitalism have its way with us. Many I have talked to feel the same. Gentrification is not inevitable if our elected representatives stand up to it. I don't know if this consideration is something that you have the authority to take into account. However, I would ask you to please to consider it and have the courage to say no to this plan. There are many other uses of the space that would benefit our community in a more equitable way.

Dear Mr. Anderson and members of the Montgomery County Planning Board.

As a resident of Takoma Park, I urge you to grant approval of Neighborhood Development Company's proposal or to redevelop Takoma Junction. As the developer has requested, your approval can be conditioned on approval from state transportation officials. No additional round of evaluation from the Takoma Park City Council is necessary, as the city has had ample opportunity to evaluate the project and was strongly supportive of the project for many years until the council abruptly and unnecessarily changed its stance last summer.

I live within a five-minute walk of Takoma Junction. Since I moved here in 2012, I have lamented the wasted space of a surface parking lot that could be so much more. Restaurants, a brewpub, office space for local businesses. This project would be a huge asset to our community, and it should not be especially controversial.

Unfortunately, the approval process for this medium-sized infill project has been long and unwieldy and threatens to deter further investment at infill sites in Takoma Park and in other parts of Montgomery County. The Maryland State Highway Administration has blocked the project for reasons that appear illogical to nonsensical. Your approval should be contingent on the SHA's eventual approval, which unfortunately may only come after litigation.

The SHA's purported concerns about the project fail to make much sense, and the agency appears insistent on blocking the process on very thin grounds that should not be endorsed by your agency. For example, the SHA appears not to take into account how much actual delivery is likely to happen on the site and seems to have performed no analysis of the timing of that traffic, and whether deliveries are likely to occur at times in which significant pedestrian/bike traffic occurs. There are pedestrians at night and on weekends, rather than during busy delivery times. There are schoolchildren at the site, but they typically cross on the other side of the street. There is no safety concern here, and the project will not meaningfully worsen traffic, pedestrian safety or biker safety.

NDC's proposal for Takoma Junction should be approved without further delay. While you may hear from many longtime opponents, rest assured that there are many in Takoma Park who do strongly support this project.

Hello- I have been a resident of Takoma Park for about 30 years and I live a block away from the Takoma Junction area where there are plans by the city to develop. I know this is coming before the County Council for vote on January 20 and I am beyond frustrated with the state of things.

When the development was proposed I was actually pretty neutral. Like many in Takoma Park, I thought development on what was a large open parking lot could be a good thing. The lot was used primarily for parking for the coop, a delivery area for large trucks and a spot for regular community events such as Earth Day, Christmas tree sales by the fire station next door, and the occasional flea market or holiday gathering. Early talk about development included maintaining a central public space that could continue to be used in this manner.

Since then, this whole process has gone completely off the rails. The city chose to partner with a development company that has expressed nothing but contempt after the initial honeymoon period when they needed community buy-in. (Did you know they talked up the idea of having a beer garden on the roof when they were first soliciting support from residents? Boy, were people excited about that.) Most troubling to me, as someone who drives and walks through this area regularly, is the way NDC has set the layby for delivery trucks right in the middle of what is already a difficult and confusing intersection. You are likely familiar with this layby as it is probably the biggest sticking point for the State Highway Association. They are right to say no to this project based on this alone. This is a dangerous situation waiting to happen: this intersection is used by many pedestrians including children walking to school and people with strollers. There is a county bus stop steps from the layby as well as a pick up and drop off point for school buses. The layby is literally right in the middle of all this foot traffic.

There are other issues that are important, too. NDC agreed to many things which are not in the current plan and, when this has been pointed out to them, they have simply waited a few months and then resubmitted the exact same plan, clearly hoping to wear the city and county down. The promised public space keeps shrinking or appearing as a privatized space. The promise that this development would benefit the coop and nearby businesses morphed into no parking allowed for any of them (this was later changed but there is no confidence that it won't be changed back once NDC gets the go ahead to move forward). NDC has refused to respond to city requests for explanations or changes. The relationship seems broken or at least dysfunctional.

I recently read the letter written by Hans Reimer to the council and I am scratching my head. I know him to be a smart, thoughtful guy and I have to assume he has simply been talking to the wrong people. Several of his arguments for approving this plan are simply wrong and some are bizarre. (I don't think *anyone* in Takoma Park wants property values to go up!). He seems to be unaware of the very real issues that are troubling the community as well as the SHA.

My fear is that the city council is suffering from a sunk costs fallacy that is keeping them from pulling out of this process and starting over-- which I wish they would do. I am hoping that the county council will be more sensible.

I've been following the NDC proposal for development at Takoma Junction in Takoma Park. I understand that NDC is asking for Conditional Approval of a traffic plan that has been rejected by by the State Highway Commission several times and an overall plan that was rejected by the City Council of Takoma Park. I urge you to deny the NDC request for Conditional Approval for the following reasons:

- I understand that the SHA has repeatedly found the proposed lay-by unsafe and NDC has resubmit the plan without making adequate safety changes. No approval, conditional or otherwise, should be granted to a plan that the SHA has deemed inadequate and unsafe. NDC's persistence in resubmitting a plan without making required structural changes that address the SHA safety concerns do not show that NDC is acting in good faith in promoting better traffic flows and avoiding vehicle and pedestrian accidents.
- The City of Takoma Park has negotiated several issues with NDC that would make the proposed development a community resource that would enhance public space and promote business development at the Takoma Junction. The Takoma Park Planners and City Council have found serious deficiencies in several areas, including: inadequate storm water management, inadequate parking for the TP/SS CO-OP and ongoing and newly developed businesses in the immediate vicinity, and lack of public community space.
- The Montgomery County Planning staff recommended disapproval of the NDC plan.

Unfortunately, there is a small but vocal opposition group in our community that would like to see this—or probably ANY--development go away. Please take the NDC proposal on its merits and weigh the good it will bring to our city.
