- Section 50.4.1.E of the Subdivision Regulations and Section 59.7.3.4.C of the Zoning Ordinance generally states that Preliminary Plans and Site Plans must be scheduled for a public hearing within 120 days after the date an application is accepted.
- The Application was accepted on December 15, 2021, which established an action date no later than April 28, 2022. The Director granted a 30-day regulatory review period extension, which established a Planning Board date no later than May 12, 2022. The Applicant is requesting a second extension until July 28, 2022 (Attachment A), which will provide sufficient time for the Applicant to address agency comments mainly related to offsite transportation improvements and acquire the necessary approvals. Granting the extension establishes a Planning Board date no later than July 28, 2022.
- Staff supports the Applicant's request to extend the review period through July 28, 2022.
