 beyond 30 days.
- On July 11, 2022, the Applicant requested that the review period for the Site Plan be extended by two months, from August 4, 2022 to October 4, 2022.
- This extension will allow the Applicant time to coordinate frontage improvements and finalize the Application.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
