Hello Chair Anderson and Commissioners Patterson, Rubin, Cichy and Verma,

In looking at the staff packet, I did not see reference to ensuring that the applicant is aware of their obligation to participate in the White Oak Science Gateway Local Area Transportation Improvement Plan (LATIP). Given the added PM peak trips of 22 and the LATIP fee of \$5,010/trip, a payment of \$110,220 will be due on this project. The Department of Permitting Services should also be advised of these details.
