- The Applicant received an approval for extension request No. 1 for three-months of the regulatory review period to December 8, 2022 from the Planning Board on November 3, 2022.
- The Applicant is requesting a one-month extension of the regulatory review period, which requires Planning Board approval. The regulatory extension for the Sketch Plan review period from December 8, 2022 to January 5, 2023 is required to adequately address final comments from Planning Staff and other agencies.
- Staff supports the Applicant's request to extend the review period with a tentative Planning Board date of January 5, 2023.
