
### Description

#### **REVIEW BASIS**

Chapter 50, 59, 22A

- Section 50.4.1.E of the Subdivision Regulations and Section 59.7.3.4.C of the Zoning Ordinance generally state that Preliminary Plans and Site Plans must be scheduled for a public hearing within 120 days after the date an application is accepted.
- Both Applications were accepted on September 7, 2022, which established a Planning Board date no later than January 5, 2023.
- The Applicant is requesting the 1<sup>st</sup> extension for a period of four months to work through the architectural design, road cross sections, vehicular and pedestrian circulation patterns, and modifications to existing stormwater facilities to accommodate recreational amenities. Staff has had multiple meetings with the applicant in recent weeks and the applicant is making good progress at addressing the outstanding issues.
- Granting the extension for four months, as requested by the Applicant, schedules a hearing before the Planning Board no later than May 4, 2023.
- Staff supports the regulatory extension period to no later than May 4, 2023.

Since DRC, Applicant has had several of these meetings with staff from multiple review agencies, including Montgomery Planning, MCDOT, and MCDPS. These meetings discussed, among other things, details on architectural design, road cross sections, vehicular circulation patterns, and potential modifications to an existing stormwater management pond. Applicant has made significant progress on working through these DRC comments, but additional time is needed to resolve them given the complexity of the remaining issues. Applicant and Planning staff agree that an extension to May 4, 2023 is appropriate to finalize this process. Applicant is also seeking a four month extension for Preliminary Plan No. 12003029B, which was concurrently filed with Site Plan No. 820230030.
