Bill Bonstra, FAIA, LEED AP is the founder and managing partner of Bonstra | Haresign Architects, LLP. After distinguishing himself at several notable Washington, DC design firms, since 2000 he has led the firm in the design and implementation of complex, mixed-use residential and commercial projects with challenging zoning and historic preservation requirements. His notable award-winning multi-family work implemented over his 39-year career includes 8700 Georgia Avenue for Roadside Development, Hotel at 1100 6th Street, NW, Ten at Clarendon, SoLo Piazza, Q14, The Aston, CITTA 50, Woodley Wardman, and the Tapies Condominium. He is currently implementing designs with challenging entitlements for 1600 North Capital Street, NW, The Barrel House, and a residential tower at 2002 11th Street, NW in collaboration with architect Phil Freelon.

With over **400 projects** under his belt, he and his work have been recognized with over 100 national and regional awards for contemporary design of new buildings, renovations, and adaptive use projects. His work has been featured in over 50 national and regional design publications including the AIA Guide to the Architecture of Washington, DC - Sixth Edition, Architectural Record, Residential Architect, Builder Magazine, Building Design + Construction, the Washington

Post, ULI/Urban Land, ArchitectureDC, Washingtonian Magazine, and in the Second Edition of James M. Goode's book Best Addresses, A Century of Washington's Distinguished Apartment Houses. For his contributions of exemplary contemporary design promoting and vitalizing historic neighborhoods in the nation's capital, he was elevated to the AIA College of Fellows, one of the highest honors bestowed to members of the architecture profession.

Graduating with honors from the University of Maryland, he continues his academic pursuits as a mentor to young architects at the firm and through his teaching, lecturing and design jury participation. He is currently teaching a Masters Design Studio at The Catholic University of America. At Maryland, he is a founding member of the Board of Visitors and Council of Advisors for both the architecture and the real estate development programs. He established the William J. Bonstra Endowed Scholarship there in 2014. In 2016, he was honored as Maryland Architecture Alumni of the Year. He is on the board of directors of Jubilee Support Alliance, Cultural Tourism DC and the International Student House in Washington, DC. He is a member of the Cosmos Club in Washington DC.



I am writing to express interest in being a member of the new Silver Spring DAP. As a resident of Silver Spring, I have a keen interest in the quality of the public realm and am excited to review projects and help to realize the new Silver Spring design guidelines as a member of the panel. Downtown Silver Spring is a wonderful community to live in; there are all the mix of uses that a resident could want and a wonderful community of residents, but because of the era in which many of the buildings were built, it is lacking in its aesthetic appeal. As a member of the Silver Spring DAP, I hope to help improve upon the existing fabric and create a place that has a more attractive built form.

In addition to my qualifications as a resident, I also have a professional interest as a licensed architect and a practicing urban designer. For 11 years, I worked for Torti Gallas and Partners both locally and nationally to design and bring projects to life that created human scale places that enhanced the built environment. They ranged from a 126-unit mixed-use building designed to be sympathetic to historic downtown Leesburg, to a 850-unit, multi-building development adjacent to Pentagon Row, nestled between the existing RiverHouse towers, to lower density neighborhoods in places like Richmond and Pittsburgh, made up of affordable and mixed-income housing.

Following my time at TGP, I decided to return to Urban Design Associates to focus more on urban design and the community led design process. During the past year working with the firm, I have had the opportunity to work both in the public and private sectors, finding creative solutions to community engagement during the covid era and leading a series of design charrettes via zoom for stakeholder driven design charrettes in places like Norfolk to participating in-person charrettes for the redevelopment of public housing into mixed-income, mixed-use neighborhoods in places like Las Vegas, Louisiana and Farmville, VA.

I am also an educator and critic. I have taught a number of studios at Catholic University and had the opportunity to be a visiting critic at the University of Maryland, the University of Notre Dame and Virginia Tech. Being a part of the academic community has honed my communication skills and allowed me to maintain a broader, aspirational view of design. It has also reinforced the skill of being a constructive critic, pushing young designers to improve their work and think not just about their individual creative intentions, but the needs of the community and stakeholders that will ultimately be the end users of their creative endeavors.

During my own time in architecture school, I had the great pleasure to participate in an interview with the architect and urbanist Jaquelin Robertson upon his winning of the Driehaus Prize for architecture. In one of his responses, he said as designers we are always designing for 3 people: our client and their needs, our individual vision as designers and finally, and most importantly, for the person who will living in our design in 200 years. As a member of the Silver Spring DAP, I will work to advocate for projects to be of a quality that they will be appreciated and loved by the future residents of my house on Greenbrier Drive.
