


Chapters 19, 22A and 50



- Section 50.4.1.E of the Subdivision Regulations provides that the Planning Board shall hold a public hearing for Preliminary Plans no later than 120 days after the date the application is accepted.
- The All Souls Cemetery Preliminary Plan Amendment application was accepted on February 23, 2022, which established a Planning Board date no later than June 23, 2022. On June 19, 2022, the Director granted a 30-day extension from June 23, 2022, to July 23, 2022. On July 14, 2022, the Planning Board granted a 3-month extension from July 23, 2022, to October 23, 2022. On November 3, 2022, the Planning Board granted a 3-month extension from October 23, 2022, to January 23, 2023.
- The Applicant is requesting a fourth extension for a period of 3 months to submit final plans that comply with the impervious limits in Special Exception H.E. 99-3 and the recommendations in the Clarksburg Special Protection Area to minimize impervious surfaces while providing safe, adequate and efficient vehicular circulation (Attachment A). Granting the extension establishes a Planning Board date no later than April 23, 2023.
- Staff recommends approval of this extension request.

Dear Mr. Johnsen:

On behalf of The Catholic Cemeteries of the Archdiocese of Washington, Inc. (the "Applicant"), we are submitting this extension request regarding the Application, which is currently under review at the Maryland-National Capital Park and Planning Commission ("M-NCPPC"). Pursuant to Section 50-4.2.F.1 of the Montgomery County Subdivision Ordinance (the "Subdivision Ordinance"), the Application is treated as an amendment to an approved preliminary plan and must follow the procedures of such. Per Section 50-4.1.E, action is required to be taken on the Application within 120 days of acceptance. As a result, action would have been required by June 23, 2022, but that was extended an initial 30 days at the request of M-NCPPC Staff via Director approval, and a second extension was then approved by the Montgomery County Planning Board (the "Planning Board") on July 14, 2022, extending the review period until October 23, 2022. A third extension was subsequently approved by the Planning Board on November 3, 2023, extending the review period until January 23, 2023. The primary reason for the third extension was because the submittal that the Applicant made to M-NCPPC Staff on August 10, 2022 did not receive any M-NCPPC Staff substantive response or feedback until October 4, 2022.

Since approval of the third extension by the Planning Board on November 3, 2023 the Applicant and M-NCPPC Staff have been in close and regular coordination, and made tremendous progress on reaching agreement, with all substantive points now resolved. However, one final extension is needed to allow time for final documentation of the agreed upon plans, and to allow time for M-NCPPC Staff to prepare their Staff Report for consideration by the Planning Board. Given the current deadline for Planning Board action (January 23, 2023), if the Applicant and M-NCPPC Staff had even one additional week they would likely be able to meet that deadline. However, given the holidays this final extension is needed. While the Applicant is requesting a new three-month extension, the Applicant firmly believes that this can be wrapped up and brought to the Planning Board early in the month of February.
