

Dear Chairman, Zyontz and Planning Board Members,

I am writing in support of the Revised Site Plan application for The Belward Campus at The Johns Hopkins University. I live in Washingtonian Woods, just across Muddy Branch Road from the Belward property. I heard many years ago about the County's vision for a life sciences center on the site. The plans in this application reflect that vision very well.

I like the fact that there are parks and other open spaces that could also be used for a farmers' market and serve as a venue for outdoor concerts, I also like that there are walking trails and bike paths with benches and areas to do outdoor exercise.

I appreciate the fact that important research will be happening on the campus. However, my major concern is potential traffic problems created by the high number of cars that will be attracted to the development by the employment opportunities there. The roads (i.e. Darnestown Road Route 28, Great Seneca Highway and Muddy Branch Road) are busy now and will only become more so after building out. During rush hours, it is difficult, and sometimes unsafe, to get out onto Muddy Branch Road from the two Midsummer Drive entrances to Washingtonian Woods. While I appreciate the development, I would like to see the traffic and transportation plans that will be implemented to provide for the added transportation needs and mitigate unsafe conditions, especially for pedestrians. I urge the Planning Board to ensure that the transportation and traffic concerns are safely, adequately and appropriately addressed, especially to meet any neighborhood concerns. I know that traffic and pedestrian issues have been a point of contention for my community in the past when previous plans were provided.

My wife and I love the Washingtonian Woods neighborhood. We have lived here for over 32 years. Like other older adult owners in the community, we plan to age in place and do a great deal of walking in the neighborhood and the new development. It's nice to know that there will be more places for us to walk just 10 minutes away. I believe that it will help increase our property values too.

I respectfully ask the Board to approve the plans with appropriate traffic mitigation actions for The Belward Campus at The Johns Hopkins University.

Good afternoon, Ms. Ball,
Thank you for the thoughtful input. I am collecting public comments on the JHU Belward Site related to regulatory reviews and will share this with both the Applicant team and the Parks Department as a recreational amenity to explore. Through the Park, Recreation, and Open Space (PROS) Plan, the Parks department has a standard process for evaluating and recommending park facility types based on various criteria. Through the Recreation Guidelines (applicable to residential projects only), both soccer fields and dog parks are identified as priority needs in the County.
From a process and timeline standpoint, we are awaiting an Application for the northern portion of the JHU Site from our Intake Division. During the imminent review period, Planning staff and the Parks Planning & Stewardship Division will work with the Applicant to implement the vision of the 2010 Great Seneca Science Corridor Master Plan, which recommends many recreation components within the proposed Muddy Branch Park, including an athletic field. Per the Master Plan, this park will be publicly accessible but privately owned. Public comments will be carried forward in future discussions regarding programming of this park.
Please feel free to stay in touch with Maren related to additional input that you may have for the broader Great Seneca Master Plan update.

Thanks for the introduction, Marilyn. Yes, as stated, I would like to find out what parties will be involved in the planning process for the "recreational" space at Belward. I know that the parks department, for whatever reason (income generating?), insists upon including soccer fields in nearly every recreational space developed. In this particular case, there are already MULTIPLE schools and other community parks in what I would call the immediate vicinity of Belward that offer such fields for use.

As someone with two dogs and two kids, I can tell you we spend enormous amounts of time at local parks and public school playgrounds. Soccer is played in a very limited window of time and when it's not getting used for soccer specifically, the space sits empty or it's used by locals who let their their dogs off leash (illegally) to chase balls and such. For those of us who choose not to let our dogs off leash in an unfenced area and for those of us who don't play soccer (there are a lot of us), we see great potential for actual use 14 hours a day, 7 days a week because dogs and most dog-park going owners don't care much about the weather. Dogs need exercise and socialization no matter how cold or hot.

Now, if you Google dog parks, you'll see two that are fairly close to North Potomac which might make a dog park at Belward seem counter-intuitive. However, both of those parks (Green Park and Mattie Stepanek) are restricted for use to City of Gaithersburg and City of Rockville residents exclusively (unless you want to risk a \$100 fine by either City). And if you've ever visited Green Park, you'd know it's lousy and not worth the risk anyway as there are practically no trees and nothing of else of interest for dogs and it's largely dusty, gray gravel and not much grass (or even grass/mulch combo which is better than gravel). These are probably all reasons that it's usually empty.

If nearby North Potomac residents and others in a Gaithersburg zip but outside City of G limits, want to take their dogs to an off-leash designated dog area, we have to drive 20 minutes on a good traffic day to Cabin John or 25 minutes to Germantown. By the time you park and get into the dog area, we're talking an hour spent just driving there and back.

Besides just advocating for the incorporation of a dog park at Belward, I would be remiss if I didn't also comment on what said dog park should include. If you are familiar with Cabin John, you'll know there are a ton of trees which provide interest for the dogs as well as a rock structure which gives dogs things to climb as well as to lay under if they need a break. Cabin John has a comfortable ground cover (mostly mulch), multiple waste bag stations around the park perimeter, two separate fenced areas to separate small dogs from big dogs, as well as a <u>water source</u> in both areas which IMO is critical. Cabin John also has two separate seating areas for human companions. Mattie Stepanek has similar amenities. The Germantown park on the other hand has some grass but a lot of gravel, nothing to climb on/under, a scant number of trees, and NO water source. I could go on about ideal dog park amenities, but I'll pause, for now.

Please let me know what it will take for Parks to consider a dog park as part of the plan for Belward, and please let me know how I can attend any related meetings/conversations/decisions, etc.
