Hello.

I would like to provide the following comments regarding the upcoming Planning Board Hearing on the Belward Campus Site Plan, Forest Conservation Plan, scheduled for March 30, 2023. As a resident of the Mission Hills neighborhood with a home directly adjacent to the Belward property, I have unique concerns regarding the implementation of this plan as well as the larger development planned for the Belward site. The comments below address the Forest Conservation Plan as well as concerns with the larger development.

First, when the original development plans were shared with the local community including residents of Mission Hills, JHU and Trammell Crow stated that the Forest Conservation Plan for the Belward Campus would include a "Mission Hills Reserve" — a buffer of newly planted trees between the homes along Mission Drive and the Belward development. Importantly, JHU/Trammell Crow originally stated that this Preserve buffer would be developed *first* and prior to the larger scale development taking place on the Belward property. This commitment was made in order to reduce, in part, the multiple impacts on homes in Mission Hills. However, in more recent discussions with the community, JHC/Trammel Crow are now stating that this is no longer the case and that the Preserve buffer will be developed simultaneously with the rest of the property. This change in commitment eliminates opportunities to mitigate the impact of the development of Mission Hill homeowners and will likely result in greater noise, dust/dirt, etc. *I request that the Planning Board ask JHU/Trammell Crow to recommit to developing the Mission Hills Preserve buffer prior to pursuing the development on the balance of the Belward property.*

Second, during the most recent presentation to the Planning Board and to the community, Trammell Crow presented their multi-phased approach included several graphics illustrating what building elements will be included in the Phase I (757,000 sf) plan. There appeared to be a discrepancy across some of the graphics in terms of what buildings would be included, notably the parking garages. I request that the Planning Board confirm with JHU/Trammell Crow that only a single parking garage structure will be included as part of the Phase 1 development.

Third, the Belward property is across the street from the current large scale development taking place at the former Montgomery County Police Training Academy (PSTA Site Plan 820220050), which is building 630 new residential dwelling units. This development has been under construction for approximately six months, and it has involved the use of very heavy machinery resulting in substantial noise to the surrounding residential communities. Since construction began, there has been development activities on the site during very early morning hours (before 7:00 AM EST) as well as on some weekend days. In order to minimize the impacts on current residents, including the residents immediately adjacent to the Belward

property in Mission Hills, I request that the Planning Board confirm with JHU/Trammell Crow that construction activities on the site will only be performed during allowed/regulated timeframes and will not include weekends.

Finally, due to the likely need to use heavy machinery similar to what is in operation at the PSTA site and which appears to be used for large rock/stone removal, I request that the Planning Board ensure that any large/heavy machinery used as part of the Belward development does not result in excessive noise or other damage to Mission Hills or to the other surrounding residential communities.

I am writing in support of the Revised Site Plan application for The Belward Campus at The Johns Hopkins University. I live in Washingtonian Woods, just across Muddy Branch Road from the Belward property. I heard many years ago about the County's vision for a life sciences center on the site. The plans in this application reflect that vision very well.

I like the fact that there are parks and other open spaces that could also be used for a farmers' market and serve as a venue for outdoor concerts, I also like that there are walking trails and bike paths with benches and areas to do outdoor exercise.

I appreciate the fact that important research will be happening on the campus. However, my major concern is potential traffic problems created by the high number of cars that will be attracted to the development by the employment opportunities there. The roads (i.e. Darnestown Road Route 28, Great Seneca Highway and Muddy Branch Road) are busy now and will only become more so after building out. During rush hours, it is difficult, and sometimes unsafe, to get out onto Muddy Branch Road from the two Midsummer Drive entrances to Washingtonian Woods. While I appreciate the development, I would like to see the traffic and transportation plans that will be implemented to provide for the added transportation needs and mitigate unsafe conditions, especially for pedestrians. I urge the Planning Board to ensure that the transportation and traffic concerns are safely, adequately and appropriately addressed, especially to meet any neighborhood concerns. I know that traffic and pedestrian issues have been a point of contention for my community in the past when previous plans were provided.

My wife and I love the Washingtonian Woods neighborhood. We have lived here for over 32 years. Like other older adult owners in the community, we plan to age in place and do a great deal of walking in the neighborhood and the new development. It's nice to know that there will be more places for us to walk just 10 minutes away. I believe that it will help increase our property values too.

I respectfully ask the Board to approve the plans with appropriate traffic mitigation actions for The Belward Campus at The Johns Hopkins University.
