### Dear chairman.

I wish to provide some feedback from the mailer I received regarding the proposed design of the Amherst Ave. bikeway between Prichard and Reedie. I saw the meeting was originally scheduled for the 30th but according to your online agenda the topic has been postponed, however I do not see any info as to when it was postponed to. Could you please inform me when this topic is to be discussed? My comments on the project are below.

1) I noticed that you are showing some planting buffers to retain some street trees, however there is no buffer in place to preserve the tree located in front of 11009 Amherst Ave, Silver Spring, MD 20902. The tree is healthy and has been there over a decade and should be saved. Please make sure to include a planting buffer to save this tree. Furthermore, I do not see any buffers for new street trees. Amherst was once lined with street trees and this would be the final opportunity to replace those trees and help alleviate the effects of removing the planting buffer.

Please seriously consider these additional tree buffers, especially the one in front of 11009 Amherst Ave, Silver Spring, MD 20902 as that tree is existing. A buffer in this location should not reduce the number of parking spaces, although perhaps one may be lost.

- 2) In the mailer you are showing a temporary easement. What is the purpose of this easement? Will the new sidewalk encroach into this temporary easement? Several homes have fences or plantings in this temporary easement area. How will these items be impacted if at all?

Good Afternoon Mr. Bzdega,

Thank you for your email and your interest in the Amherst Avenue Bikeway project. We appreciate you taking the time to write to us and share your thoughts with us. Your comments has been received and included in the overall public engagement documentation.

Please see below for the responses to your comments/questions.

- 1) The permeable parking bays are proposed to accommodate the on-street parking needs for residents along this side of Amherst Avenue, but we can certainly revisit the possibility of saving the tree you are referencing. Often times, the root zone of the tree could be much larger underneath the subsurface and even excavating in the surrounding area could jeopardize the root zone and increase the chance of tree falling over in the storm events or high winds.
- 2) The temporary easement indicated on the newsletter are proposed temporary construction easements that the County will have to obtain from each property owner for the purpose of constructing the parking bays and reconstructing portion of the sidewalk in the front. Temporary construction easement is only temporary during the construction period as the name suggested, and it will expire after construction activities are complete. The County will work with each property owner to determine the extents of the easement needs and negotiate appropriate compensation for it. Please note that the property line shown on the newsletter is based on the GIS database and not completely accurate. We are currently tasking our consultants to formally survey the property lines for each property on this block.
- 3) The permeable parking bays are currently proposed using the PaveDrain products, which require less maintenance than traditional permeable pavement construction methods. The County has applied this similar strategy using this product elsewhere, namely the Sligo Parks Hills near downtown Silver Spring and Sligo Creek. Our counterparts at the Department of Environmental Protection are responsible for maintaining SWM facilities across the County, and they have regular maintenance schedule once they are constructed.
