## Description

Request to extend review period for the Sketch Plan and Preliminary Plan from April 27, 2023 to June 22, 2023. This is the fourth extension request. The Sketch and Preliminary Plans propose to redevelop a surface parking lot and vacant commercial development into a mixed-use development with up to 500 residential units and 108,965 square feet of commercial development. The project is located at 1776 East Jefferson Street, zoned CRT-2.25 C-0.75 R-1.5 H-150 on 6.52 acres within the 2018 *White Flint 2 Sector Plan*.

- On March 9, 2023, the Planning Board approved Extension Request #3, extending the review period for the Sketch and Preliminary Plans from March 9, 2023 to April 27, 2023.
- The Applicant requests an extension for both Applications to be heard concurrently to ensure the most efficient use of the Planning Department and Planning Board's resources and to address all agency comments.
