Summary

- Section 50.4.1.E of the Subdivision Regulations generally states that Preliminary Plans must be scheduled for a public hearing within 120 days after the date an application is accepted.
- The Application was accepted on January 15, 2022, which established a Planning Board date no later than May 12, 2022. Thereafter, The Applicant was granted two additional extensions by the Planning Board, establishing a new Planning Board date not later than May 11, 2023.
- The Applicant is requesting an additional 2-month extension until July 13, 2023 (Attachment A), to address minor site design comments and acquire the necessary agency approval letters. Granting the extension establishes a Planning Board date no later than July 13, 2023.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance.
- Staff supports the Applicant’s request to extend the review period through July 13, 2023.
