- Section 59.6.3.B of the Zoning Ordinance states that an Administrative Subdivision Plan generally follows a 90-day review period. The Planning Board may extend this review period.
- The Applicant has requested, in an application dated May 3, 2023, that the review period for the Administrative Subdivision Plan be extended from May 25, 2023 to July 27, 2023.
- This extension will allow the Applicant additional time to address neighbor comments, reduce impacts to specimen trees, and obtain agency approval letters for stormwater management, MCDOT, and a Fire Department Access plan.
- The Planning Board hearing on the application may take place before the end of the review period and will be publicly noticed in accordance with the Zoning Ordinance. This is the first extension request associated with the subject project.
